Shore birds, ducks, and other water birds should be present in abundance and variety, including Snowy Plovers, Semipalmated Plovers, and Whimbrels. This trip will end at noon. Those wishing to continue longer, or to visit the Junior Museum at Coyote Point will find good picnic areas at the Point. Waterproof footwear and warm clothing are recommended.

NOTE: The following unusual sightings were made at Coyote Point by several of our members on the Shore Survey:

Nov. 29 - A Common Murre about 50 feet offshore.

Dec. 13 - A female Old Squaw Duck, 100-200 feet offshore.

Birding was good. We saw forty-two species, including Western and Eared Grebes, Red-throated and Common Loons, Surf and Common Scoters, Brown Pelican, Black Brant, California Murre, Pelagic and Double-crested Cormorants, four kinds of Hawks and seven kinds of

Someone had been shooting birds and we saw both dead and crippled birds of several species.

Before going to the Point we huddled and reviewed the geology of the area, as planned.

When we all became hungry we were quite happy to go to the McClellan cottage at Moss Beach and eat our picnic lunches in warm comfort, still watching birds (and the ocean) through the picture windows.

SAWYER CAMP ROAD - Saturday, December 11, started out clear and beautiful, but soon settled down to steady rain.

Despite the rain, the hardy Auduboners had a good time, and got fifty species of birds on the Leader's list. Some of the party may have seen species not listed by the leader.

We missed the Wood Ducks seen on the lakes a few days before; but our list at the end of the six mile trip from the dam at San Mateo Creek to the dam at Millbrae included such prizes as Common Loon, Canvas-back Duck, Golden-eye Duck, Gadwall, Ring-necked Duck, Red-breasted Merganser, Hooded Merganser, Canada Goose, Band-tailed Pigeon, Varied Thrush, and Spotted Sandpiper.

### CONSERVATION NOTES

Conservation work today is rather akin to the everwidening circles created by a pebble thrown in water. A person might begin conservation work by being interested in saving a grove of trees or a rare bird and pretty soon he's concerned with the overall quality of his environment, and conservation becomes a problem of aesthetics as well as the wise e of natural resources. All of us will admit that we will not be able save every remaining tree and open hillside in California, for obviously ing up the world's shortest books. Here are a few more: there is going to be increasing development. The problem is to insist that development not destroy the natural characteristics of the land and that it be done aesthetically, that is in good taste. For instance the Tahoe area could have been developed in a rustic spirit in keeping with its natural beauty, rather like the towns in the Swiss Alps. It need not have turned into the Miami Beach of the Sierra. Our own El Camino Real could have had business along it, but if there had been strong sign ordinances, treesleft in place and some architectural control it would still have been attractive. The neon signs, the gas station and hamburger stand architecture, the sheer vulgarity of our development must be controlled if we are to save California from looking like one gigantic amuse-\* \* \* \* \* \* \* \* \* \* \*

Hearings are being held in Washington concerning the plans for a National Redwood Park. As you know there has been strong opposition from the lumber industry and there has also been a great speed-up in cutting of virgin stands. Time is running out for the redwoods. The Sierra Club in a full page announcement in the "Chronicle" urged letters to the Governor and the President. Why not take ten minutes of your time and write these letters to help save trees that have been growing

After hearing STRONG opposition from property owners against the planned scenic parkway along Skyline the San Mateo County Planning Commission turned down both plans offered by the Staff. They then appointed a citizens' committee (made up primarily of property owners) to study the area involved and offer their own plan for Skyline. Interim zoning ends January 20th and it is believed the Commission will ask to have it extended again. \* \* \* \* \* \* \* \* \* \*

San Bruno Mountain still stands . . . but just barely. The big black and of development and excavation for bayfill still looms over its head. · The City of South San Francisco has finally taken the lead to help preserve it by sending a recommendation to San Mateo Supervisors urging San Bruno Mountain be kept as a regional park. This recommendation has been passed on to the Regional Planning Committee and the Parkand Recreation Department. It should certainly be considered seriously as this mountain represents the only open space remaining in heavily populated Northern San Mateo County.

#### SHORE SURVEY

The long program we have been conducting for the Department of Fish and Game will come to an end with our counts at the end of the year. # PESCADERO CREEK MARSH AREA

As reported in the November "SEQUOIA", a committee was appointed to study the developments planned by the State for the marsh area around the mouth of Pescadero Creek. This committee has held several meetings some at the marsh, to study the plans, and is now in the process of writing to the Division of Beaches and Parks responsible for the program to make our recommendations. Although the desires of the Division are commendable, it is our feeling that their plans will not accomplish what they want, and we are making counter suggestions. At present it is not feasible to present these here, but as future developments occur, we will keep our membership advised through the Bulletin.
