Twenty-two persons with sharp eyes and sensitive ears were able to see and report the following: Common Loons, Double-crested Cormorants, Black-crowned Night Heron, four Grebe species, Snow Goose, Cackling Goose, Ring-necked Duck, Willet, five species of gulls, Virginia Rail, Red-breasted and Pygmy Nuthatch, Bewick's and Marsh Wrens, Audubon's Warbler, and Yellowthroat. And - oh - yes, numerous black chickens (American Coots).

"WATCH-BIRDS"

Birdwatchers are urged to apply their talents of observation to surveillance of our elected representatives actions pertaining to environmental quality. Try regularly to attend city council meetings and city and county planning commission meetings and report to Peninsula Conservation Center any actions adversely affecting environmental quality. Become familiar with what to expect of your elected officials attitudes and let them know of your support or opposition. Most important environmental decisions are made by governmental bodies -- when we, as environmentalists and their constituents, fail to impress them with our objectives, the developers move in and always win.
