REPORT ON FIELD TRIP TO ALUM ROCK PARK ON JANUARY 29th.

Following several cold, gloomy days with occasional rain, this day was one of clear blue skies and sunshine. The highlight was the sight of two Golden Eagles soaring overhead, with an attack by a Red-tailed Hawk on one of them affording a dramatic comparison of relative size.

Another unexpected sight was that of a flock of White-throated Swifts circling about. A few saw a Water Ouzel and a Canyon Wren. The Nuttall's Woodpecker and Red-breasted Sapsucker were well observed. Picnic lunch was enjoyed together beside the creek. The Mt. Hamilton road was closed because of snow at the higher elevation.

UNUSUAL SIGHTINGS

White Crested Laughing Thrush -- Native of Southeast Asia. Two birds observed in San Francisco by Charles Newman, Bonnie and Jed McClellan.

Mandarin Duck - Native of China, Japan. Observed by Bonnie and Jed McClellan and Leroy Nelson in Foster City.

Barrow's Goldeneye - Rare visitor this far south. Three birds observed by Bonnie and Jed McClellan in Foster City.

Eagles -- An immature Bald Eagle was observed at Foster City and at Pulgas Temple by Al Bergeron and Leroy Nelson. An immature Golden Eagle was seen at Pescadero Marsh by the same observers.

CONSERVATION NOTES

SEQUOIA REPRESENTED ON EQCC: Dr. Ruth Smith has accepted the appointment of the Sequoia Audubon board to represent us on San Mateo County's Environmental Quality Coordinating Council. The Council, formed in 1971 to act as an advisory group to the County Board of Supervisors, is headed by Claire Dedrick, an influential and dedicated conservationist who was a key figure in the successful effort to create the Bay Conservation and Development Commission (BCDC). One of the first matters of EQCC attention will be San Bruno Mountain.

<u>U.S. CORPS OF ENGINEERS' EXTENDED JURISDICTION:</u> A recent announcement by the U.S. Corps of Engineers is very encouraging in providing stregthened protection of Baylands. Its jurisdiction has been extended to include dikes, sloughs and salt ponds; previously the Corp only exercised control over navigable waters. This means that any filling of diked areas will require a permit from the Corps and the 1969 National Environmental Policy Act requires the Corps to prepare environmental impact statements before granting those permits. Additionally, the 1958 Fish and Wildlife

Coordination Act requires that the Corps consult with the U.S. Bureau of Sport Fisheries and Wildlife before issuing permits thus adding further environmental controls over Corps-regulated projects. (However, the new control regulation is not retroactive and will not affect land fills and diked areas already created in the bay.) This announcement has been hailed as a landmark decision by conservationists.

NATURAL ENVIRONMENTAL STUDIES - U.C. EXTENSION: The University of California Extension offers many enticing short courses in Bay area flora and fauna in its Spring, 1972 issue of "Natural Environmental Studies" catalog. Among them: (1) San Bruno Mountain, weekend of April 7 - 9, timed to the wildflower display; (2) April 7 - 9, Asilomar, "Heroes in the Seaweed - Seashore Biology"; (3) April 29-30, "Native Flowering Plants and Conifers of the Bay Area", in cooperation with the California Native Plant Society at Botanical Garden, Berkeley campus.

PESCADERO MARSH

On invitation from the State Park people, a committee from Sequoia Audubon visited Pescadero Marsh on Sunday, February 6th, and staked out an access trail. The trail route will provide adequate access with minimum disturbance and will help in visitor control. Al Bergeron will recruit some work parties soon for actual trail construction.

The Pescadero Marsh has been a "project" of Sequoia Audubon for several years. Members who have not yet visited the area should plan to do so. Drive to Half Moon Bay, then south on the Coast Highway to the mouth of Pescadero Creek. Come home via Pescadero, Memorial Park, La Honda, Skylonda Thence north on Skyline or drop down into Woodside for a very pleasant Spring ride.

AUDUBON CANYON RANCH

The Ranch, two or three miles north of Stinson Beach, is sponsored by Golden Gate, Marin and Sequoia Audubon Societies. In the past eleven years the property has grown to include four canyons fronting on Bolinas Lagoon plus some recently-acquired holdings on Tomales Bay. The center of interest is the original canyon where extensive visitor facilities have been established including a trail system, heronry overlook, book store, picnic tables and natural history museum. The public is invited on Saturday and Sunday during the months of March through the first weekend in July. Common Egrets and Great Blue Herons may be observed nesting in the tops of redwood trees.

Sequoia Audubon Society will provide "Hosts" for the month of June and volunteers will soon be asked to sign up.
