FIELD TRIP REPORTS:

Pescadero Marsh and Beach -- September 22 -- Mark Zumsteg, Leader

Over 60 birders enjoyed a clear, almost windless day with the temperature in the high sixties, observing 66 species. The trip started at 8:00 AM and concluded about 1:30 PM. The following species were seen: Red-throated Loon, Eared and Western Grebes, Sooty Shearwater, Brown Pelican, Brandt's and Pelagic Cormorants, Great Blue Heron, Common Egret, Snowy Egret, American Bittern, Pintail and Cinnamon Ducks, Whit winged and Surf Scoters, Turkey Vulture, Red-tailed Hawk, Marsh Hawk, Sparrow Hawk, California Quail, Virginia and Sora Rail, American Coot, Black Oystercatcher, Killdeer, American and Black-bellied Plover, Surfbird, Black Turnstone, Wandering Tattler, Willet, Greater and Lesser Yellowlegs, Knot, Pectoral and Least Sandpipers, Dowitcher (sp) Western Sandpiper, Marbled Godwit, Sanderling; Glaucus-winged, Western. H erring, Ring-billed, Bonaparte's, and Heermann's Gulls; Common Murre, Marbled Murrelet, Band-tailed Pigeon, Anna's Hummingbird, Belted Kingfisher, Common Flicker, Downy Woodpecker, Black Phoebe, Barn Swallow, Chestnut-backed Chickadee, Bushtit, Wrentit, Long-billed Marsh Wren, Starling, Yellowthroat, Redwinged Blackbird, Brewer's Blackbird, Lesser Goldfinch, White-crowned and Song Sparrow.

Pt. Reyes Bird Observatory -- September 29 -- Byron Davies, Leader

Bob Stewart of the PRBO professional staff, outlined the Observatory programs to over 20 Sequoia members and guests. It is always surprising, even to experienced birders, to see how small even the most familiar birds are when they're in hand for banding. Banding, while still continued, is no longer as heavily emphasized in the Observatory studies as it has been; current efforts are aimed more toward behavorial studies such as those involving raptor/prey relationships at Bolinas Lagoon. We did not compile a formal species list for this trip but a few of the more interesting birds noted, somewhat incidentally, were: Bl.-cr. Night Heron, Green-winged Teal, Sharpshinned Hawk, Cooper's Hawk, Red-shouldered Hawk, Greater Yellowlegs, Baird's Sandpiper, Brown Creeper and Winter Wren. A female Wrentit gave her distinct call and one party lunched under a group of

eucalyptus where hundreds of Monarch butterflies had congregated.

Marin Headlands and Rodeo Lagoon -- October 7 -- Byron Davies, Leader

Eleven ardent birders endured rain, fog, mist, drizzle and more rain from 8:00 AM until 11:00. The weather cleared after they arrived home, damp and defeated. No hawk migration. The following species were observed: Pied-billed Grebe, Brown Pelican (Incl. Juv), Great Blue Heron, Common and Snowy Egret, Bl.-Cr. Night Heron, Mallard, Cooper's Hawk, Marsh Hawk, California Quail, American Coot, Long-billed Curlew, Willet, Marbled Godwit, American Avocet, Glaucous-winged, Western, and Heermann's Gulls; Great H orned Owl, Anna's H ummingbird, Red-shafted Flicker, Black Phoebe, Scrub Jay, Common Raven, Wrentit, Winter Wren, Robin, Loggerhead Shrike, Starling, Western Meadowlark, Redwinged Blackbird, Brewer's Blackbird, House Finch, Lesser Goldfinch, Brown Towhee, White-crowned, Golden-crowned, Fox and Song Sparrow.

Gazos Creek Road -- October 13 -- Mark Zumsteg, Leader

Beautiful skies, warm temperatures and lots of enthusiasm made this Eco-Series trip most enjoyable! Fifty species of plants were identified including Woodwardia, Fern, Creek Dogwood, Red Alders and a beautiful Liverwort. Also noted were many fungi and lichens. Invertebrates were numerous. Vertebrates were not so numerous; 23 birds, 2 snakes, and one mouse. Birds observed: Turkey Vulture, Cooper's and Red-tailed Hawk, California Quail, Band-tailed Pigeon, Red-shafted Flicker, Hairy Woodpecker, Downy Woodpecker, Western Flycatcher, Steller's Jay, Chestnut-backed Chickadee, Brown Creeper, Wrentit, Winter and Bewick's Wren, Golden-crowned Kinglet, Ruby-crowned Kinglet, Audubon's Warbler, Furple Finch, Pine Siskin, Rufous-sided Towhee, Golden-crowned and Song Sparrow.

OCTOBER PROGRAM NOTES By Nancy Bentz

BIRD CALL OF THE MONTH: Charles Newman's tape presentation was the loud melodious whistle of the familiar Olive-sided Flycatcher, with a Rufous-sided Towhee in the background.

PLANT OF THE MONTH: Jed McClellan treated us to a look at the pretty and delicate Grass of Parnassus (not a grass at all, but a member of the Saxifrage Family) named after Mt. Parnassus in Greece. The pale yellow flower blooms in the autumn in marshes and bogs of the California coastal ranges and the Sierra Nevada. His slides were taken at Mt. Tamalpais and up in Plumas County.

PRAIRIE FALCON COUNTRY was the special topic of the evening, presented by Mr. Phil Gordon of the Ohlone Audubon Society. The savannah country of golden grasslands and oaks, near the San Antonio Reservoir and Sunol Park in Alameda County, has been the stage for the past two years of a dramatic round-the-clock, eight-week vigil over the Flag H ill aerie of the magnificent Prairie Falcon, an endangered species.

A determined group of Ohlone naturalists volunteered to camp, in two-day to one-week shifts, above the cliff-side nest to drive away the potential nest robbers and alert nearby State Park employees. The "watchmen" were threatened and harassed by the irate falconers, who cut their phone lines as many as three times a day! They warded off

several nest robbers each day and the last few weeks it became necessary to heighten security by stationing a State vehicle near the campsite.

When asked how so many falconers had learned of the nest site, Mr. Gordon explained that a detailed article had appeared in the Oakland Tribune, describing not only the location of the nest but even methods of capture! Consequently, falconers of all ages arrived, well armed with ropes and climbing gear. One man flashed a State badge trying to "con" his way down to the nest. Fortunately, the distrustful naturalists stopped him and learned later that his shiny badge had long expired.

There were unbelievable slides of the just-hatched fledglings with great black eyes and pink gaping mouths and of the adult falcons in flight. The Prairie Falcon, Mr. Gordon explained, is a coursing bird with strong, low flight who preys mainly on other birds hitting them at great speeds (as high as 185 mph) with their toes. One slide captured a falcon pausing unfalteringly in midflight to scratch his ear.

The watchful naturalists had an unusual opportunity to observe not only the falcons but the surrounding wildlife of the area. They kept a detailed ledger and took incredible pictures. During the eight week vigil they identified 84 species of birds. Mr. Gordon's slides were a visual delight: an Acorn Woodpecker in his many-holed tree; a Horned Lark; a Bushtit in an elderberry tree; a Lark Sparrow perched amid the Bull Thistle; a Meadowlark; the black-masked Western Kingbird; the Golden Eagle, competitor of the falcon; the small whiskered cousin of the Prairie Falcon, the Sparrow Hawk. At night they heard coyotes and the dove-like call of the Pygmy Owl.

The first year of the vigil five falcons were fledged. This year, two. They'll be back next spring on Flag Hill to play "midwife" again to a most deserving bunch of youngsters.

CONSERVATION NEWS

Though most Audubon members probably already know, it will do no harm to repeat the good news that the Oil Sump Bill, AB2209, was signed into law by Governor Reagan. Further cause for rejoicing by "birders" and other conservationists was the consummation of the proposed land swap between the State Lands Commission and Mobil Oil Co. reported in last month's "Sequoia." This gives the State title to 900 acres of marshland on Bair Island and about the perimeter of Redwood Shores (with the possible later addition of up to 800 acres more on Bair Island) which will be designated as a wildlife refuge.

S.A.S. members should be on the alert for the new San Pedro County Park conceptual plan now being developed at a time when the North Coast Water District will have a request for doubled water use from San Pedro Creek. The State Department of Fish and Game now believes original estimates of water flow necessary to maintain San Pedro Creek as a viable steelhead stream were too low and they may renew their protest of the present amount of water use. The County Park is on the upper reaches of the Middle Fork of San Pedro Creek.

The Environmental Quality Coordinating Council has sent a letter to the State Water Resources Control Board supporting a request of the

Pacifica Creek Protection Comittee (concerning the Water Company's application #23733) that minimum stream flow should be sufficient to maintain the present ecological structure of San Fedro Creek. As an E.Q.C.C. member, S.A.S. endorses this but similar letters of support written by individual members will also be helpful. Though this is not a crucial election year, some important local issues will be coming before the voters in November. Menlo Park voters will decide on a \$1.8 million bond issue to purchase the 38-acre "Hill" the last large open area in the city. San Carlos will have a \$5.9 million bond issue for general park and open space acquisition and development including, most importantly, \$1.1 million for purchase of the Hassler Health Home property owned by the City of San Francisco. Pacifica will have two ballot measures: Measure D is a referendum to overturn the Council's zoning of 330 acres from Agriculture and R-1 to Planned Development which will allow 805 units of multi-story development. The Council-sponsored Measure F would provide for purchase of the land.

Probably the most controversial measure on the ballot is Proposition 1, the Tax Initiative. This is opposed by several conservation organizations in the County including the Sierra Club, Committee for Green Foothills and Coastal Alliance, and as of the middle of October none had come out in favor of it. A debate between Assemblyman Dixon Arnett and Senator Arlen Gregorio on the Proposition will be held in the Burlingame City Hall on October 31, at 8:00 PM.

National Audubon has noted that two recent developments in the field of nuclear power remind us that it "is still far from a proven answer to the Energy Crisis. For safety reasons, pending further study, the Atomic Energy Commission has reduced maximum allowed outputs of 10 of the 34 nuclear power plants now in operation in the United States. And a law suit filed by the Natural Resources Defense Council questions the safety of radioactive waste disposal at the AEC facility at Hanford, Washington, the nation's oldest dumping ground for such wasts, where leaks from underground storage tanks have been detected. Until there is full assurance of safe and efficient nuclear power, environmentalists must continue to insist on conservation measures to curb wasteful uses of power -- in order to make remaining supplies of oil and coal last longer." This means you and me as well as the other guy.

NEW BIRD NAMES

The A.O.U. (American Ornithologists Union) has issued Supplement 32 in THE AUK for April, 1973, making certain changes in the "official" bird names. Present names are based on the A.O.U. "Check-list of North American Birds" (5th edition, 1957). It would seem reasonable that in spite of the supplement of April, 1973, present names would continue to be acceptable until the 6th edition is published and existing field guides and printed lists are revised.
