### SIGHTINGS:

Bald Eagles: Several people have seen Bald Eagles in San Mateo County recently. Apparently there were altogether two adults and two immature. Most of the sightings have been along the Spring Valley Lakes, but on December 23, Brandt Jobst saw one near the old San Gregorio store.

Hawks: On January 8, Bonnie and I saw a Swainson's Hawk circling lazily over North Burlingame. On January 12, Charles Newman reported a Sharp-shinned Hawk sitting in a street tree in San Francisco, eating a Pigeon. Several people have noticed an unusual number of Roughlegged Hawks along the Coast and on January 10, Robert Sandel reported one at Foster City. John Giguette saw one, also, at Belmont Slough, on December 29.

White-tailed Kites: In December, Mrs. Fred Dodge reported seeing two White-tailed Kites in Menlo Park. Neil Dickinson checked out the sighting and saw three. John Giguette saw a White-tailed Kite on December 29 at Belmont Slough.

<u>Clapper Rails</u>: Dr. Fox recently saw a Clapper Rail on the Burlingame bay front and John Giguette saw one at Belmont Slough.

Albino Blackbird: On January 10, Bonnie and I saw a Blackbird in Golden Gate Park that was almost completely white. It was flying and feeding in a flock of normal Blackbirds.

Red Phalarope: 4,000 at Pacific Grove, January 11. (P.M., B.S.)

Northern Shrike: One at Gray Lodge, W.M.A., January 2. (P.M.)

One Brown Thrasher and two Snow Buntings at Honey Lake, December 28.

Harris' Sparrow: Four, located in a flock of Golden-crowneds at Putah Creek, Yolo County, December 29. (P.M.)
\*\*Snowy Owl: One, at Año Nuevo Point, January 13. (P.M., B.S.)

\*\* Many others have seen the Snowy Owl, so many, in fact, that some have expressed concern that so many people moving in on him may keep him from hunting food and suggest that observers watch him from as great a distance as possible. He is a daytime feeder and probably came this far from his arctic habitat because of scarcity of food.

## WESTERN AUDUBON CONFERENCE:

By now all members should have received "Audubon Conservation Topics, West" describing the Asilomar Conference on April 6--9, 1974. Let us know if you have not and we will see if we can get you a copy.

THE ENERGY CRISIS, probably the most popular topic at present, may be annoying for most of us and even more serious for some. But it does have its good side, too. Gasoline shortages and high prices should lessen air pollution even with relaxed air standards. And pressure is rapidly building up to bring the mass transit conservationists have long been advocating. A county-wide bus system similar to that in Santa Clara County is in the forseeable future, as is a mini-bus system for Menlo Park. Having been forced temporarily to become a non-driver, I have been using the Redwood City municipal bus system and find it both comfortable and convenient. I can therefore wholeheartedly urge all Sequoia Audubon Society members to support their local bus whenever possible.

Another plus on the energy scene is the naming of National Audubon's Executive Vice-President, Charles Callison, as a member of the eightman advisory board to Federal Energy Administrator, William Simon.

Oregon's Senator Mark Hatfield is sponsoring a federal bill (S.2062) which would OUTLAW NONRETURNABLE BEVERAGE CONTAINERS, as does Oregon's own state law. The Senate Commerce Committee will be holding hearings on it probably in February. Letters concerning the bill can be sent to SENATOR JOHN TUNNEY, SENATE OFFICE BUILDING, WASHINGTON, D.C. 20510, who is a member of the Committee.

On the local scene, our CENTRAL COASTAL COMMISSION is starting a series of hearings to promote public input for planning concepts for the Coast. The first will have already been held in Pescadero in January. A second has been scheduled on the marine environment which should be of particular interest to Sequoia members. It will be held February 6 at 7:30 PM at Skyline College, San Bruno.

Those little Mercury Batteries found in cameras, watches and hearing aids have been polluting our environment by the hundreds of thousands. The 383-000-member Telephone Pioneers of America, national organization of retired telephone workers, has a program to recycle them. A commitment of \$50 was made to the Boy Scouts as encouragement for a contemplated Burlingame tideland clean-up.

President Bergeron saw a preview of George Anderson's new movie on the marshes and estuaries of California -- including Pescadero Marsh. This seems to be an excellent picture. It will be shown at the April Asilomar conference.

Our Crystal Springs (main) Christmas Count should post about 166 species and the ano Nuevo Count perhaps 146. The post count "Soup Feed" arranged by the Social committee was a great success.

Charles Newman reported receipt of a generous contribution to our Land Acquisition Fund from Mr. and Mrs. Richard Elwood of Hillsborough. The Board gratefully acknowledged and accepted this gift.

# JANUARY REGULAR MEETING -- January 10, 1974

Larry Green, West Coast Field Editor of the magazine Field and Stream, showed us a series of interesting and artistic slides of water birds. For the most part, these pictures were the surplus shots Larry took as illustrations for his magazine articles. Larry is an excellent photographer, a careful observer and a charming speaker. He mentioned that he has evolved from a hunter of birds to an "appreciator" and that his shooting now is with his camera. He is an Audubon member and considers his magazine, Field and Stream, a good advocate of conservation.

Larry told us that his working career has included 37 different occupations and that he had been fired from 35 of them. One of the first, at age 16, was as a professional "bird caller" for wild fowl hunters. His activities at present include teaching nature subjects at Skyline College night classes.

It was suggested by Larry that Sequoia members who wish to "bird" in the Lake Camanche area or in the Delta area generally, contact Dick Gaumer at 2431 Rutledge Way in Stockton, CA 95207, phone 209-478-1469. Mr. Gaumer is well informed on current birding conditions and will be glad to share his knowledge. The password is that Larry Green referred you at the January Sequoia Audubon meeting.

Jed McClellan's plant of the month was the Western Sycamore. His pictures and commentary were of the usual high quality we have come to expect and appreciate. While this tree is wide-spread in California, it is not native in San Mateo County. We recall a beautiful stand along the Nacimiento River just east of Nacimiento Summit in Monterey County.

Charles Newman, using the same tape recording equipment as President Nixon, didn't have any blanks on his tape of Mexican birds. He played for us the calls of the Sora Rail, Streak-backed Oriole and the Bright-rumped Attila which he had recorded in San Blas on his December trip.

## NATURAL HISTORY OF HAWAII:

The natural history of Hawaii--its geology, evolutionary history, and its native plants and animals--will be explored this spring in a nine-day study tour presented by University of California Extension as part of its Natural Environment Studies program. The study tour is scheduled May 18-26, and enrollment is open to any adult interested in the wild heritage of the islands.

Focusing on the aesthetic qualities and scientific value of Hawaii and Maui, the program takes participants from the great active volcano of Kilauea to the rarely seen upper verge of east Maui's lush rain forests. Leading authorities on island biology will conduct the expedition, which traverses the native forests of Mauna Loa and Mauna Kea, the unique dry forests and the luxuriant puus of leeward Hawaii, and windward high slopes of Haleakala. Special attention will be given to native plants and birds and to the significance of human impact on the island ecosystems.

The public should be alert to this campaign and recognize it for what it is — simply an effort to slow down or avoid getting on with the job of cleaning up pollution. It is a fear campaign which seeks to capitalize on the anxieties and uncertainties of the public concerning our energy problems. It probably signals a major assault on the Clean Air Act."
