REGULAR MONTHLY MEMBERSHIP MEETING, NOVEMBER 9, THURSDAY, 8:00 PM at the San Mateo Garden Center, located on Parkside Way--between 26th and 27th Avenues--just west of Alameda de las Pulgas in San Mateo.

Our guest speaker will be Mr. Warren Nute, Civil Engineer from San Rafael, California and a member of Marin Audubon Society. Mr. Nute was responsible for designing the MOUNTAIN VIEW Sanitary district's sewage treatment facility visible from Highway 680, east of Martinez. The unique feature of this plant is that it has created a freshwater marsh, supported by the converted waste water. Mt. Diablo Audubon Society recently awarded an Audubon Chapter Industrial citation to the Mountain View Sanitary District for its role in developing a fresh water marsh. The eight-acre marsh has provided habitat for over 40 water related bird species and numerous mammals, amphibians and invertebrates.

Plan to see and enjoy this slide show of this unique area in Contra Costa County and then participate in the November 11 field trip.

#### October 14 - Marin Headlands

On a cool, foggy day, fifteen birders got good looks at Snowy and Common egrets, Great Blue herons and Black-crowned Night herons. A Green heron gave us a good show by circling and landing nearby for all to see. A Say's phoebe sang to us from a low Coyote bush on the hill. Red-tailed hawks and kestrels were grounded due to the fog, so we got to see them sitting on poles. Sharp-shinned hawks were seen flying over Hawk Mountain before it fogged in. Later, at Tiburon, we saw Yellow-rumped warblers and a Spotted sandpiper was

feeding on the beach at Richardson's Bay. Forty-nine species were seen before we had lunch under the trees at Audubon's Western Education Center.

#### CONSERVATION NEWS:

The Alaska Lands Bill which SAS members had joined with a nation-wide coalition of conservationists to support, failed in the Senate on the eve of Congressional adjournment. A frantic stop-gap bill was being composed at the time of this writing to extend protection of Alaska lands for another year. Otherwise such protection will end December 18 and all will become open to

development. Passage of such a bill by both Houses would be extremely unlikely before adjournment. If Congressional action failed entirely, Secretary of the Interior Andrus said he will attempt to set aside much of the land considered in the bill under an already existing law.

Another Congressional blow against conservation, however, was countered by President Carter's veto of the Public Works Bill and Congress failed to override. The bill contained six of the nine water projects which the President and conservationists considered both economically and environmentally unsound. SAS members should thank Rep. The Senate passed the Omnibus Parks Bill, supported by Senator Cranston but opposed by Senator Hayakawa. The latter particularly opposed the transfer in the Bill of Mineral King from the Forest Service to Sequoia National Park, as he favored the Disneyland ski development. The Parks Bill would also set aside 70,000 acres in the Santa Monica Mountains as a National Recreation Area. This ties in with the bill passed by the State Legislature and signed by Governor Brown last month to acquire state park lands in the Santa Monica Mountains but only if federal funding is made available in the Omnibus Parks Bill for federal reimbursement of the state.

The Governor also signed the bill funding study of riparian forests along designated water courses in the Central Valley, the Tulare Basin and the California Desert. This will hopefully form a basis for protection of this fast-vanishing resource.

State Senator Foran who represents a small northern segment of San Mateo County, introduced an amendment to S.1667, an essentially unrelated bill, in the last two weeks of the Legislative session. This would have required plaintiffs seeking to enjoin projects presumably violating the Environmental Quality Act to post a bond covering costs and damages from possible delays of the project. This would have created a financial means test for judicial review, and it was, fortunately, not passed in this session. However, the issue will very probably be brought up again in the 1979 session.

Finally, and most importantly, don't forget November 7th--Election Day--will soon be here. Above all, don't forget to vote!

There will not be the excitement to be expected in the presidential election year, but seats in both the House of Representatives and the State Legislature are open. Congressman Paul N. McCloskey, Jr., in Southern San Mateo County and State Senator Arlen Gregorio, who have

both consistently supported conservation issues, will be facing challengers Kirsten Olsen and Marz Garcia respectively.

Among those running for County posts, former Burlingame Mayor and boat owner, A. C. Harrison and Sierra Club member Rick Thurber, are running as a team for seats on the San Mateo County Harbor Commission with the unusual platform of voting themselves out of office if elected. They advocate dissolution of this special District and return of its functions to the Board of Supervisors. None of the other candidates, so far as is known, hold this view.

#### CHRISTMAS BIRD COUNT 1978

The Sequoia Audubon Board is pleased to announce the appointment of Peter Metropulos as Compiler of our Crystal Springs Bird Count which will be held on December 30 this year. Peter is a student of Natural Sciences at San Francisco State University and is known by all of us since he has been a member of Sequoia Audubon Society since the age of twelve. We are especially fortunate in having such a dedicated ornithologist to compile our Annual Christmas Bird Count.

Christmas Bird Counts are of great ornithological value. Since 1974 our Crystal Springs species count has gone from eighteenth to seventh place among birding organizations in the United States. In order to maintain this record we are going to need the help of every birder in Sequoia Audubon Society.

AUDUBON CANYON RANCH is a 1000-acre wildlife sanctuary and education center located on Bolinas Lagoon three miles north of Stinson Beach on State Highway 1. It is open to the public on weekends and holidays from March 1 through July 4 each year. Special visits may be arranged by phoning the Ranch, 383-1644. The Ranch is sponsored by Golden Gate, Marin and Sequoia Audubon Societies. In 1969 the Ranch was designated by the U. S. Department of the Interior as a Registered Natural Landmark.

NEWS FROM THE RANCH -- from Betty Boyd

Highlights from Helen Pratt's Report - The Great Blues occupied nests on about January 31 and commenced laying about March 1. On the 29th of the month the first eggs were hatched. There were 43 pairs of Herons, two more than last year; and 66 young were raised. Losses consisted of a brood from one nest before fledging and 12 nests lost all of their eggs before hatching. Great Horned owls were suspected in these losses. The brooding pair average of 1.5 per pair approximates that of the average for the last 11 years.

About March 12 the Great egrets began to gather in the herony. The first egret egg was laid between the afternoon of March 26 and the next morning. Breeding pairs numbered 88, an increase of four over 1977, and 139 young were raised. The proportion of nesting attempts losing chicks (18%) was less than it has been in four years and fewer nests (14%) lost eggs. The last young egrets left on August 9.

The Ranch is deeply grateful to the Directors of the Bothin Helping Fund for a grant of \$12,500 which the Fund has just made towards the completion of the new Education Center in Volunteer Canyon. This grant has made it possible for ACR to start work on the enlargement and remodelling of the main farm house in the canyon. This will be used for an assembly hall and student center for the education program there.

#### OCTOBER GENERAL MEETING:

Our speaker, Ron LeValley, Biologist with the Point Reyes Bird Observatory, has been doing research with sea and land birds and marine mammals on the Farallone Islands since 1968. On these granite islands, 27 miles offshore of San Francisco, nearly 350 species of birds have been recorded. During breeding season as many as a quarter-million adult nesting birds may be found.

Since 1969, these tiny islands have been a National Wildlife Refuge. They are staffed the year around by a small band of biologists from PRBO who are aided by volunteers, some of whom work on the Islands, while others, like those from the Oceanic Society, transport personnel and supplies. PRBO staff conducts one of the most intensive programs in research in the United States, research not only on birds but on the varieties of whale, seal and shark which make their homes on and around the Farallones.

These now-protected Islands are the largest breeding seabird colony in the 48 States. But it was not always so. For many decades they were exploited for bird eggs and meat, especially the Common Murre. The seals were taken for their fur and oil. And destruction was rampant by people wandering unrestrained over the Islands during critical nesting periods. In contrast, it was a pleasure to hear Ron tell us about the present, protected, superabundant wildlife now found there and to see his slides of some of the species inhabiting the Islands.

Frank Allen presented our Bird-of-the-Month, Brewer's sparrow which he described humorously as "a basic sparrow." This rather colorless little bird is redeemed by its musical song "suggesting a canary but weaker" (Peterson).

### SAN FRANCISCO BAY NATIONAL WILDLIFE REFUGE:

The Federal District Court in San Francisco on September 26, 1978, granted possession to the U.S. Fish and Wildlife Service of 15,000 acres of land in the south Bay. The land consists mostly of salt ponds used by the Leslie Salt Co. for the production of salt. Leslie's use of the ponds for salt production will continue.

The Refuge administration is now authorized to post and patrol the area and manage it for refuge purposes. Hunting will not be permitted until the Service has approved a Public Use Plan for the

refuge. The area will remain closed to entry until it is made safe and ready for use by the public.

### OCTOBER BOARD OF DIRECTORS MEETING:

Jean Jones reported that Dr. Martyr, National Audubon representative in Sacramento, will attend the October 28 field trip to Pescadero Marsh.

#### BARRY SAUPPE:

Barry recently wrote Fran and Roy Nelson describing some of his Vancouver, B.C. birding. Here are some excerpts:

"The birding as usual is exciting around here. In the past week I found a rusty blackbird which there are only a few records for the Vancouver area, and a broad-winged hawk which there is no record in the Vancouver area. Up to four sharp-tailed sandpipers have been seen off and on at Iona for the past month, and a few stilt sandpipers have been around also. On a boat trip out of Westport, Washington Suann and I saw 110 B-F Albatross, 5 Fulmar, 26 Pinkfoots, 35 New Zealands, 250 Sooties, 2 Short-tailed shearwater, 8 Fork-tailed storm-petrels, 1 red phalarope, 3 Parasitic Jaegers, 15 Pomarine Jaegers, 3 Skuas, 4 Kittiwakes, 1 Arctic Tern, 300 Murres, 5 Tufted Puffins, 45 Rhinoceros Auklets, 450 Cassin's Auklets, 4 Sabine's Gulls,  $\underline{12}$  Xantus' Murrelets, and one Flesh-footed Shearwater. Kind of a nice assortment. This weekend I'm going out on another pelagic trip off of Bamfield on the west side of Vancouver Island. They go out as far as 30 miles on that one if weather permits. Possibilities this time of year might be scaled petrel, horned puffin, parakeet auklet, laysan albatross and who knows what else."

Barry also sent a copy of DISCOVERY, the quarterly newsletter of the Vancouver Natural History Society. On the front cover appears an excellent photograph of the Spoon-bill Sandpiper which Barry discovered on July 30 at the Iona Island Sewage Treatment Plant. Hundreds of birders visited the site during the five days (July 30 to August 3) this rare bird was present. Visitors came from all West Coast States plus Arizona, Idaho, Connecticut, Ohio, Tennessee, from five Canadian Provinces and parties already birding nearby from France, Belgium and Germany. A special viewing tower was erected by local authorities. The bird had not been observed previously in Canada. Barry was using a Swift Master spotting scope with a 45X eyepiece.

The Spoon-bill Sandpiper breeds in northeastern Siberia and winters in Indochina, Burma and India.
