## FROM THE EDITOR

MARCH D PRINCEIGN HARSON. The only sheltered harbor between Santa Croz and San Francisco, Princeton Harbor is winter home to a good variety of bay ducks. Icons, cormorants and other divers as well as quilis and shorebirds. An oldsquaw, a glaucous gull and a rock sandpiper, were seen here on a single day in December and the area almost always has one or two surprises. Snowy blovers and brant can be expected at this time of year and some of the shorebirds and looms should be changing into their breeding plumages. To get there take Hwy. 92 to Hwy. 1 and follow Hwy. I north to Capistrano Rd. Using the radar antennae on Pillar Point Hill as a quide follow the streets of Princeton to the base of the hill and bark at the intersection of West Point Avenue (the road to the radar station) and an extremely poor dirt road leading to the The meeting time will be 8:30 so that we can avoid some of the dirt bike and RV activity on the beach. This will be a short walk with some areas of broken footing, so boots are recommended. The trip should break up at moon.

# FARALLONES REPORT

Late December and January weather on the Farallones was relatively mild but an east wind made landing operations rough.

The aftermath of the oil spill continued to provide only minor problems and the phenomenon of the red swimming crabs continued well north of their usual range.

The southward migration of the gray whales peaked on January 14 with 62 sightings. The beginning of the northward migration will follow almost immediately as adult males and non-breeding females head for the feeding grounds of the Arctic. The last of the migration will occur in late March, April and sometimes even into May as the mothers and calves return north.

California sea lions numbered 900-1000 on the islands - about half of last year's El Nino inflated population. Many of this year's sea lions seem to be tame and friendly but are actually sick and may be dying from the infestation of Leptospirosis parasites.

This is also the peak of the elephant seal season. Most of the sub-adult bulls have left since the islands are primarily an adult reproductive zone. The female population is down 10% and the male population nearly 20%. This is within normal variation and not considered any reason for alarm. The mild weather has enhanced the survival chances for the pups and only a few have been lost, these through trampling by the large bulls. Records have now been kept long enough so that some third generation births can be identified. These are an exception though, since most of the Farallon #lephant seals are immigrants, not off-pring of earlier years. The total population in late January was approximately 300 pups, 350 females and 114 bulls. By the first of March most of the (emales will have gone, leaving their pups (now weighing 350 pounds) to fend for about themselves.

The Cassin's autlets temporarily left the island in January but are expected back for spring breeding. A flock of pine siskins were the only land birds noted in January but the cattle egrets that strayed to the sland in December lingered on, but were slowly starving to death.

The lack of rain and the unfavorable winds at the landing sites created some problems for the humans on the island but the Coast Guard was finally able to deliver a new water pump and avoid a crisis.

# MOGUDUA SAMES ANDUBON

April 26, 1985 marks the 200th anniversary of the birth of one of the most famous wildlife artists in America, John James Audubon.

Although the exact origin of Audubon is cloaked in mystery, this pales into insignificance when compare to his accomplishments.

Audubon was extremely talented in many areas. He was an expert dancer, marksman, swordsman and skater. He could speak fluent French, Spanish and English and he could paint or draw with either hand, or both at the same time.

It was his artistic talent, however, that led to his place in the history books. In the early 1800's, little was known about the wilds of America or its bird life. The task that Audubon assigned himself, to depict in lifesize the birds of America, was to consume the rest of his life, most of the family wealth and result in several business failures. In 1809 Audubon embarked on this monumental effort and until 1838, he worked night and day to accomplish his task. Throughout this effort, his one constant support was his wife, Lucy Bakewell Audubon. She and their two sons, John W. and Victor, were constantly left to fend for themselves as John James would be off in search of new birds or subscribers. Even when Audubon spent nearly 13 years in England supervising the final printing and securing subscriptions, Lucy supported his efforts, expending most of her inheritance to do so.

In 1838, Birds of America was published. Subscriptions for the 435 plates in 4 volumes were sold for \$1000 (Equivalent to more than \$50,000 in today's terms). For the first time, pictures and descriptions of birds were brought into the homes of many who probably had never even considered the worth of a bird. One can most assuredly trace the history of "bird watching" as a hobby to the release of Birds of America. Bird watching leads to other pursuits, such as the study of forests, wetlands, prairies, etc. The case could be made that the tap root of the entire conservation movement began to form with the publication of the Birds of America.

Even after Audubon's death in 1851, Lucy went on supporting his work. In 1868, at the age of 70, she was teaching at her home, using his art as a teaching aid. One of her students, George Grinnell, would later become editor of Forest and Stream magazine and in 1886 would found the Audubon Society.

In some ways the work of today's Audubon Society is similar to that of Audubon. The efforts of our chapters to save an endangered species, a wetland or establish educational programs are sometimes long and difficult. The rewards for these efforts, however, will last forever.

# COUNTERPOINT

Men who accomplish great deeds are not always great men. And so it was with Audubon. Some anecdotes from his early years show that his genius did not go far beyond his obsession with birds. The illegismate son of a French colonial planter, John James was sent to the United States.

to avoid conscription. The family wealth was dissipated by colonial revolution and when he married Eucy Bakewell, Audubon was a comparatively poor man. Yet through his life he retained the airs and egotism of the colonial lord.

Using Lucy's dowry as capital Audubon set up as a storekeeper in Louisville, where the two major events of his life were a shooting match with the aging Daniel Boone and a meeting with Alexander Wilson who tried to sell him a subscription to his soon to be published <u>American Ornithology</u>. It was at this meeting that the germ of Audubon's later obsession was planted.

He soon moved downriver to Hendersonville, his partner managed the few goods in the store while Audubon hunted, fished and sketched. He went through several businesses and partners and supported himself more through his services as a quide and his skills as an outdoorsman than his business acumen. He left the town in disgrace. bankrupt, accused of fraud by his partners and followed by subpoena servers after having stabbed a business acquaintance in a street brawl. Shortly after his departure another man with whom he had quarreled was found shot to death. Since victim had been known to be involved in a number of shady dealings no formal investigation was made. Frontier justice did not concern itself overly with private quarrels.

Months later, having lived day to day by his outdoor skills and occasional portrait commissions he was able to bring Lucy to New Orleans where she was able to support her family by working as a governess. Audubon had acquired a reputation as a "ladies" man" and many believed that his limited success as a portraitist was more due to his charm than his talent. Since he had no knowledge of oil painting and little skill at water colors at this time, the conclusion is not surprising. On a least two occasions he was challenged to duel, be his reputation as one of the finest marksmen along the river caused the challengers to withdraw.

Wanderlust prevailed again and he set off into the wild, turning up more than a year later in Philadelphia. Philadelphia was still the largest city in the land and the center of scientific research. Audubon found that some of his drawings and a legend as a backwoods naturalist had preceded him. He became friends with Lucius Bonaparte and was invited to attend a meeting of the Academy of Arts and Sciences. The euphoria was short-lived. Arrogant in his contempt for the drawings of Titian Peale and the deceased Alexander Wilson, and headstrong in the defense of his own, he was goaded into making stupid and illtimed remarks and made a life-long enemy of George Ord, the Academy's most prestigious member. Audubon guaranteed that no Philadelphia firm would reproduce his paintings when he responded to a request for some technical corrections to his drawings with a series of personal insults to the engraver. Joseph Mason, a former student partner of Auduban's attempted to come to his belp but was rebuffed when Audubon refused to acknowredge that he had bed any assistance of any kind.

Nevertheress, he gained ecough support to finance a true to England where he remained until the completion of his masterwork. For the rest of his fife he was to go on making enemies and abandoning triends but his growing regulation and his backwoods image were to guarantee his success.

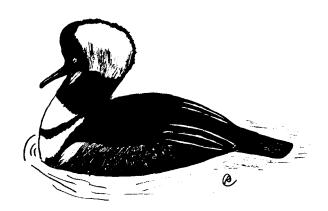

# COYOTE POINT MUSEUM

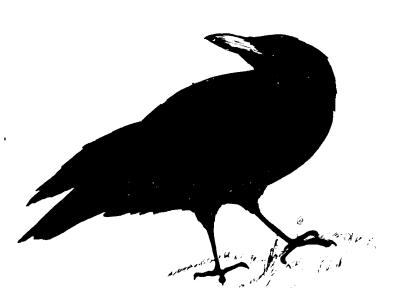

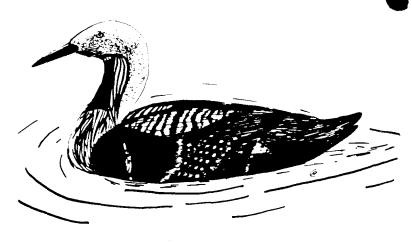

THE DITCH WON'T DIE! Assemblyman Stirling has introduced AB15 which would direct the Department of Water Resources to construct the Delta facilities of the State Water Project, including a through Delta canal.

THE CONVEYOR, the newsletter of the California Grain & Feed Association has this to say about the Kesterson Refuge, "The Foreau of Reclamation estimates that it would nost more than \$500 million to line the ponds with clav. By law, the Bureau would have to pass the costs on to the farmers who utilize the San Luis Drain."

"The alternative to cleaning up Kesterson is to close the San Luis Drain and would fake an estimated 42000 acres of farmiand out of production...and remove (.5 billion from the region's economy. West side communities such as Firebaugh and Mendota would rease to exist."

"The implications of the Kesterson decision will impact agriculture throughout California. Water quality in the Sacramento River, Tulare Basin and Salton Sea are just a few areas where further actions may be taken..."

Background information should include information on the nominee's volunteer or paid work, community activities and pertinent educational or professional affiliations. The inclusion of supporting documents and peer recommendations is encouraged but not required.

The Sequoia Audubon award committee may not necessarily present an award in every category.

The awards will be presented at the Sequoia Audubon general meeting on June 13, 1985. The public is invited.

Nominees for community awards need not be members of the Audubon Society

#### CHAPTER AWARDS

LEADERSHIP - To be given to a member who has demonstrated an exceptional commitment and dedication to the goals and membership of the Sequoia Audubon Society.

ACTIVITY - To be given to a chapter member who has improved or developed and implemented an activities program which contributes to the goals and purposes of Sequoia Audubon.

#### COMMUNITY AWARDS

One or more awards in each of five categories may be given to individuals, groups, businesses or government agencies for projects or activities within San Mateo County.

ENVIRONMENTAL EDUCATION - To be given to those who, through public education, have contributed to the better understanding of the interdependence of natural resources and the need for protecting native ecosystems.

ENERGY AND RESOURCE CONSERVATION - To be given to those whose work has resulted in a significant reduction in energy consumption; who have contributed to progress in the use of substitute renewable energy sources; Or who have demonstrated strong commitment to the conservation/recycling of all limited, non-renewable natural resources.

URBAN ENHANCEMENT - To be given to those who have demonstrated or successfully promoted environmentally sensitive development or rehabilitation in the urban areas of San Mateo County

OPEN SPACE/UNIQUE ECOSYSTEM PRESERVATION - To be given to those who have defended and protected the public trust and worked for the preservation and protection of open space or unique ecosystems within San Mateo County.

RESEARCH — To be given to those whose research in the field or in the laboratory has added significantly to the knowledge of the native ecosystems of San Mateo County.

# ENVIRONMENTALIST OF THE YEAR

This award is to be presented to the nominee who has achieved outstanding success in the protection and improvement of San Mateo County's environmental quality. The recipient will be chosen from among the finalists in the above categories.
