#### FROM THE PRESIDENT

SEP.14 MOUNTAIN VIEW FOREBAY — In recent years this has become one of better areas for observing shorebirds when high tide forces them off the mudflats. This trip is scheduled on the rising tide when the shoretirds will be arriving at this area to feed and rest. Fectoral, semi-palmated, sharp-tailed, Baird's and stilt sandpipers have all been seen here in recent migrations and least terms used it as a staging area last year. We will meet at 9:00 AM at the foot of San Antonio Road near the entrance to Mountainview Shoreline Park. To get there take Hwy. 101 south to San Antonio Road and take the San Antonio Road (North) exit. Follow San Antonio Road for a short distance until it makes a right angle turn and becomes Terminal Road. Stop and park as close to the intersection as is feasible. Trip will break up at noon.

POINT REYES FIELD TRIP. A search through the SEP 21 AY "warbler traps" of Point Reyes can yield almost anything at this time of year. We'll be looking inland and eastern vagrants but can expect migrants some early arriving winter residents as well. Walking SUNDAY and some early arriving winter residents as well. will be minimal but sturdy shoes are recommended. Clothing should be layered since the weather on Pt. Reyes is extremely changeable. Although fall is normally the most pleasant time of year on Point Reyes keep in mind that it has the coolest average summer temperature in the continental US. We will meet at the new Point Reyes National Seashore Headquarters building at 9:00 AM. To get there take Hwy 101 or I-280 north to Hwy 1. Take Hwy 1 across the Golden Gate Bridge where it once again joins 101. Follow 101 north to the San Anselmo-San Quentin exit and take a left at the bottom of the ramp. You will now be on Sir Francis Drake Boulevard. Follow this all the way to Olema. At Olema, take a right at the stop sign and within a hundred yards take a left. In about half a mile, you will come to the Headquarters complex. The trip will take place rain or shine. Bring lunch. The trip normally lasts until 2 PM. Anyone interested in car-pooling should call the Audubon office (593-7368) or the leader.

## NEWS FROM THE RANCH

# JEANNE PRICE

Gilman Hall, the rehabilitated barn at the Bouverie Preserve, was dedicated July 26 and properly celebrated will food, music and speeches of appreciation. The handsome, high-ceilinged building designed by Clifford Conly and David Bouverie will serve as the center of educational activities at the Preserve, providing a library, a kitchen, a laboratory and offices as well as a light and airy assembly and exhibit hall.

The new facility is named in honor of its principal donor, the Gilman Family Foundation of New York City. Sylvia Gilman attended the dedication. In his remarks, David Bouverie acknowledged the generosity of the Gilmans saying, "We are five to six years ahead of schedule thanks to the Gilman family."

At the invitation of staff member Edris Cole, US Supreme Court Justice Sandra Day O'Connor and some friends visited the Bolinas Preserve in July. Edris took them to the gverion where they spent about a half hour viewing the nesting birds. From all reports Justice O'Connor, whom Edris found to be warm and personable, was most enthusiastic about the Ranch, calling it the highlight of her trip to Marin.

This all came about through a chance encounter with a former Ranch visitor the bread shelf of Ed's Superette Stinson Beach.

Final figures for the spring season at Bolinas show a metabric rise of visitors and a slight decline in breeding birds. Heronry expert Helen Pratt reported 21 pairs of herons and 96 pairs of egrets this year.

Five thousand more visitors came to the Preserve this season than in any previous year for a total of 19,000 through June 19, according to Manager Skip Schwartz.

At Bouverie 60 groups visited during the spring for a total of 2000 visitors guided by a volunteer staff of 54 participating docents. Bolinas had 63 school classes visit this spring for a total of 1876 children with 76 participating docents.

QUOTES I'D RATHER NOT HAVE HEARD

#### THE URBAN SPARROW

#### CLIFF RICHER

received more of a reaction to May's rticle on the "lonely" white-crowned sparrow of Rincon Annex than to any other article in the three years I've been doing NEEDLES. (This vast outpouring of comments consisted of two letters, a postcard, two phone calls and a half-dozen comments at meetings or field trips.)

Those of you who may have been concerned as I was about the fate of our dispossessed sparrow can take heart. Two days after the June NEEDLES went to press. I emerged from my office building and heard - faintly - the unmistakeable song of a white-crowned sparrow. The evening rush hour was well underway so it took me some time to locate the singer over the traffic noise. Finally, I found him, in the canopy of one of the new plantings outside the Federal Reserve Bank Building above one of the busiest intersections on Market Street. Over and over he sang his song, accompanied by the clanging of the cable-car bell and the roar of the diesel buses. The bird was quite tame and I was able to get close enough to see a familiar triangular shaped break in the line above the left eye. It was "my" sparrow!

I have to admit that my emotions were out of all proportion to the significance of the event and when I finally urned my back on this tiny survivor I had a new appreciation for the aptness of the old cliche about "a spring in my step and a song in my heart."

As it turned out he was not exclusively my sparrow after all.

Sheila Davies wrote, "Your Rincon Annex friend not only most probably survived but may have moved to a more up-market address: Montgomery and Post. This spring as I came up the Crocker Plaza steps from BART I could hear that wonderful white-crown sound to greet me. About six floors up, on the Crocker Bank building, there he was, perched on a railing round a box hedge. A few weeks later he moved to a roof garden on the other side of the street. I heard him again this morning (May 14, 1986) but his song is less assertive now."

"You must have had different office hours when I was walking down Spear Street several years ago. Otherwise, you would have seen one passer-by stop and return the greeting."

Thanks also go to Dick and Sandra Eckstein and to Helen Davies for their kind remarks.

August, the white-crowned sparrows are usually silent so I've lost track of this tiny survivor but I'll let all of you know when I hear him again in the spring.

#### BIRDING CLASSES--SAN FRANCISCO

Free evening birding classes are being offered through the San Francisco Community College District. Although classes started in August, students may enroll at any time during the 18 week semester. Just go directly to the classroom indicated, near the intersection of Judson and Phelan Avenues at City College of San Francisco on the days and hours shown below. Parking is available in the North Reservoir off Phelan Avenue. A parking fee of \$7.50 per semester may be charged. The Balboa BART station is adjacent to the college.

Each class stresses identification, status and habits of North American birds in a two-and-a-half hour weekly slide lecture. The text for all classes is *Field Guide to the Birds of North America* by the National Geographic Society. The instructor is Joe Morlan, co-author of *Birds of Northern California* and compiler of the weekly recorded Northern California Rare Bird Alert.

Ornithology I is an introduction to avian biology. It stresses concepts in modern ornithology, including behavior, population ecology and evolution; illustrated primarily by common Bay Area birds. It meets Tuesdays starting August 19 from 7-9:30 PM in Room 268 of the Arts Building Extension.

<u>Ornithology II</u> is an in-depth systematic treatment of identification and status of landbirds including flycatchers, swallows, wrens, thrushes and vireos. It meets Wednesdays starting August 20 from 7-9:30 PM in Room 310 of the Arts Building.

<u>Ornithology III</u> will cover waterbirds including grebes, seabirds, pelicans, cormorants and herons. It meets Thursdays starting August 21 from 7-9:30 PM in Room 268 of the Arts Building Extension.

These classes are sponsored by Golden Gate Audubon Society as a public service and all evening classes are free of charge. Optional field trips may be arranged on weekends. The fee will be \$32 for seven half-day trips. Please bring binoculars and field guides to all classes if you have them. #### MOND LAKE NEWS

The winter of 1985-1986 was very good for Mond Lake. In February, torrential storms forced the Los Angeles Decartment of Power and Light to stop diverting water from the lake's trioutaries. By mid-summer the lake was at its highest level since 1974.

The storms that caused Fresident Reagan to declare Mono County a disaster area and had Tioga Fass closed beyond its usual opening day were a miracle for Mono Lake's guils. The rising waters once again isolated Negit Island and made it impossible for land predators to reach the guils' eggs and chicks. Almost six times as many gulls nested on Negit Island in 1986 as in 1985 but the totals were still less than 5% of what they were in 1978.

Torrents of water roared down Rush Dreek almost washing out the back roads from the South Tufa Preserve to Lee Vining and making the culvert over the creek impassible except for the most foothardy drivers.

However, DWP continued to divert every possible drop of water. Lee Vining, Walker and Parker creeks remained dry until runoff finally breached the Lee Vining dam in May. "We have no intention of releasing water if we can avoid it." said DWP attorney Kenneth Downey while DWP engineer LeVal Line told the California Water Commission that "there is no degradation of the environment in the Mono Lake area."

Faced with this kind of intransigence, the Mono Lake Committee feels it has no choice but to defend Mono Lake through the courts, the Legislature and public censure. Governor Deukmajian continues to be deluged with letters to save the lake and has had to hire full-time staff just to answer mail on this one subject.

Nevertheless, the Governor remains uncommitted on the issue and his opponent in this fall's election is diligently trying to avoid it. Mayor Bradley's plan to end the traditional North-South water disputes ignores Mono Lake entirely. Both candidates claim to be "studying" thew problem.

#### MONO LAKE LAWSUITS: AN UPDATE

THE PUBLIC TRUST SUIT, filed by the Mono Lake Committee, National Audubon, Friends of the Earth and three individual landowners in 1979 is the only suit which seeks to protect the lake itself. This suit pits the "public trust" doctrine against state water rights policies. This case has been shuffled from court to court. In 1984 the US District Court ruled that the public trust portion of the suit should return to the Alpine County Superior Court and a federal nuisance claim based on alkali dust pollution should remain in Federal Court. This is being appealed by all parties with the Mono Lake Committee, et.al., asking for all matters to be retained at the federal level while DWP and the state are asking that all matters to be returned to the county and ultimately to the state water board.

THE RUSH CREEK SUIT has been deferred while the State Department of Fish and Game studies the stream to determine what flow levels are needed to keep the creek healthy. These studies are expected to take two to three years, but meanwhile the water continues to flow at 19 cubic feet per second (or more) into Mono Lake.

THE WATER LICENSE SUIT is an offshoot of the Rush Creek action. and asks the court to void DWP's licenses to divert water from any of the Mono Lake feeder streams. Hearings are continuing through the summer on this but no trial date has been set.

#### WRITE A BETTER LETTER

Today, perhaps more than ever before citizens are expressing their concerns to public officials. Interest groups mobilize their members and activists in sophisticated, coordinated campaigns through telegrams, phone banks, media work and personal visits. But even with all the different lobbying strategies that abound, one of the easiest and most effective ways of getting your message across is still the simple, direct personal letter.

Some people ask "why not give me a prewritten postcard or message that I can simply drop in the mail?" The truth is postcard campaigns have little impact on influencing the position of public officials. They realize how little effort it takes to slap a stamp on a postcard. In fact, congres—sional offices are often so inundated with preprinted messages that it's sometimes difficult to answer the real letter writers.

Some points to remember when writing letters to your public officials:

- 1. BE BRIEF. Try to keep your letter to a single page. Focus on one issue per letter.
- 2. BE DIRECT. Identify the issue (refer to a bill by bill number if possible and say what action you want the official to take. Ask for a specific position or commitment.
- 3. DON'T MENTION YOUR MEMBERSHIP IN AN ORGANIZATION. The official probably knows the organization's position. They want to know what you, a voter, think about an issue and how it affects you and your region.
- 4. THANK THE OFFICIAL if they have taken a correct stand on a previous issue. You will be showing your awareness of their record and they will appreciate the praise in light of the letters from those constituents whose views differ from your own.
- 5. FOLLOW UP. By writing back you will show your continued interest in the issue and will increase your credibility with the public official and their staff.

One of the greatest ironies about writing constituent letters is that after taking the time to compose something original and thoughtful, you are likely to receive a pre-written response! Don't dismay. If the response you receive is either a form letter or too vague, feel free to write back and ask for a clearer response. After all, each public official has to respond to thousands of citizen Constituent letters are still a representative's primary form of vota contact.

#### PCL MIDYEAR REPORT

At mid-year the Flanning and Conservation League has a mixed report on environmental legislation this year.

It does not appear that the Urban Open Space Bond Act will make it to the ballot this year since the competition for ballot space is so intense. For this reason, the PCL is considering sponsoring an initiative to place this on the ballot in the next general election. Such an initiative has to be planned carefully and strategically designed so as to gain the maximum public support while not competing with other environmental bond acts. A proposed initiative will be presented to the PCL board this month.

On the legislative side there were the following hits and misses:

SB 1600 -- The Tahoe Compact Bill was supported by correspondence and testimony, passed by the legislature and signed by the Governor.

SB 1717 --- The Urban Open Space Bond Act passed both the Senate and Assembly but was withdrawn after the legislatures and Governor's office reviewed all of the proposed bond acts and found that they exceeded the legal limit.

AB 2668 ----- Bond Act to Improve Drinking Water Systems included a PCL amendment providing for water conservation and was passed and signed.

AB 2977 -- Lead Poisoning Study in children. Passed and PCL is appealing to the Governor for signature.

Most bills die in committee and never reach the Assembly floor. At the mid-point there were some important bills that never made it:

AB 3598 - A \$600 Bond Act for Construction of the Auburn Dam died after opposition from PCL. A major victory.

AB 3096 -- Restriction of Coastal Access. Opposed and died. AB 3049 -- Deregulating Pollution Control Devices on Used Cars. Strongly opposed by PCL. Died in committee.

AB 2908 ----- Prohibiting Hook-up Moratoriums where sewer capacity was inadequate. Died in Ways and Means after heavy PCL opposition. A worthwhile victory.

AB 2907 --- Reducing the Authority of Local Government to Regulate Housing Developments. Strongly opposed by PCL and died in committee. A major victory.

AB 2228 — Requiring the State Water Board to Set Standards to Protect SF Bay. PCL was unable to come up with acceptable wording and it died in committee.

AB 1279 - Allowing Illuminated Billboards to Carry General Advertising. Defeated twice but will probably resurface

next year.

AB 540 -- A Bill to Simplify the California Tax Code which would eliminate the checkoffs. Died in committee but will

be back after Federal Tax Reform is completed. SB 2612 -- The Return of Duke's Ditch died but may be resurrected again (and again).

SB 2458 — An East Bay MUD Bill that started out with good intentions but ended up with bad amendments. Killed by legislative counsel.

SB 2427 -- Relaxing Standards for Orange County Landfills. Vigorously opposed and apparently dead.

SCA 31 - Toxics Bill of Rights. Supported but died in the Senate Appropriations Committee.

Since this is an election year PCL spent a considerable amount of time working on budget items, concentrating on "motherhood and apple pie" environmental issues.

Urban Streams Funding - blue-pencilled out by Governor.

Tahoe Conservancy - funding to purchase critical habitat. Agreed to by the Governor.

Lake Tahoe Water Quality Study Continued Funding - Signed. San Joaquin and Sacramento River Funding -"Control" language inserted by PCL and designed to restrict rep-rapping was vetoed out by the Governor.

Toxics Enforcement and Education - vetoed out by Governor.

wherever possible. coordinators will arrange for recycling collected debris to symbolize the goal of resource conservation.

The event's organizers include representatives from the Coastal Commission, the State Management Board. Californians Against Waste, the California Conservation Corps and RecyCal.

"This is a chance for us to give back, in a personal way, some of the value we get from our magnificent coastline," said Coastal Commission spokesman Jac Liebster. "We hope many chapter members will join in the cleanup and develop other Coastweek activities."

# COMPLETE THE REFUGE

The Citizens Committee to Complete the Refuge has received a \$2500 matching grant from Save San Francisco Bay Association. # DESERT TORTOISES

Linda Kypta reports that she now has temporary custody of a second desert tortoise which she is fostering on behalf of Wildlife Rescue.

Obviously both of these creatures are well out of their normal range and were undoubtedly picked up by well-meaning animal lovers.

However, the Bureau of Land Management reminds us that the desert tortoise is an endangered species. Their education program has worked too well in that many tortoises have been turned in to the desert offices of the BLM for "protection" so they have had to clarify their intent.

Barstow Area Manager Alden Sievers urges citizens not to take them home or to a BLM office but to simply allow them to continue on their way. If they are crossing a highway or road drivers should stop for them or go around them. They should not be picked up except for their own safety and then they must be moved gently as they become easily frightened when picked up. When frightened they eliminate their body ter, leaving them vulnerable to death dehydration.

The desert tortoise is protected by state law. It cannot be collected or harassed and a permit is required to keep it in captivity

#### MARINE ENTANGLEMENT MENACE

Marine entanglement and the incidental take of nontarget marine species by the fishing industry is an enormous problem that has only begun to be addressed. Plastic nontfilament nets, soda and beer can holders and other plastic litter annually entangles thousands of marine mammals. sea birds, sea turtles and nontarget fish.

The National Academy of Sciences estimates that over 298 million pounds of plastic fishing nets, buoys and lines are lost annually by commercial fishermen, while over 52 million pounds of plastic packaging are thrown overboard. Japan alone leaves 1624 miles of "ghost net" (discarded or lost nets) during the five month fishing season. These ghost nets continue to entangle marine animals for years.

Corrective steps are being taken but progress is slow. Congress recently approved \$750,000 in funding to the National Marine Fisheries Service. (NFMS) to help solve the problem. Other steps include a bill recently introduced by Senator John Chafee (R-RI) which will ban plastic six-pack and bottle holders, replacing them with bio-degradable alternatives.

Environmental organizations have expressed unanimous support for the US ratification of Annex V of the 1978 Protocol of the International Convention for the Prevention of Pollution from Ships (MARPOL). The MARPOL Treaty would provide stringent regulations for discharge at sea of ship-generated garbage. Most importantly, it would prohibit the disposal of plastics and other synthetic materials, including fishing nets. Ratification depends upon the Coast Guard receiving public support.

Most of the plastic debris ultimately ends up on the world's beaches. Beach cleanup efforts have therefore become important voluntary activities, helping officials pinpoint pollution sources. Last year the California effort resulted in volunteers cleaning up 300 miles of coastline, collecting tons of debris.

This year's national beach cleanup campaign, Coastweek '86 is scheduled for September 20-October 14. (See the separate related article in this issue.)

Urge them to support US ratification of MARPOL Annex V, and support federal regulations to stop plastic disposal at sea.
