### FROM THE PRESIDENT

# CLIFF RICHER REMEMBER THIS IS A DOUBLE ISSUE!

Because of budget considerations and the Editor's increasingly heavy invovement with the Christmas Bird Counts, (more on that later) there will be no January issue of the NEEDLES. So if there's something going on in January that you don't want to miss, be sure and keep this issue for an extra month.

#### THE CHRISTMAS COUNTS

A lot of birders, and most of the participants in the annual Christmas Counts think of them as great fun and to most of us they are just that. But I - to tell the truth -  $\underline{\text{don't}}$  enjoy them. Now that sounds like rank sacrilege. But it's the awful truth. I enjoy identifying birds. I enjoy watching them. But I don't enjoy counting and recording them.

So why is it that I'm going to be freezing my bottom off at 12:01 A.M. on the morning of the Christmas Count straining my ears to hear rails and owls? Why have I endured 50 mile per hour winds and horizontal rain while trying to out-wait a rock sandpiper? And why have I once again volunteered to be the substitute compiler for this year's counts?

Repayment. Just as people in ancient times poured a little wine onto the ground to repay the gods, so do I try in a small way to repay Sequoia Audubon and birding for the enjoyment they have brought me. By contributing this time and this effort I am helping to build and maintain the largest single wildlife data base in the world. If I count 6 less coots and two fewer mergansers on this year's count than on last year's it's meaningless, but if everyone counts fewer coots and mergansers, it will be like an alarm bell going off.

So whether you do it for repayment, for duty, for fun or for curiousity - do it! Sign up for this year's Christmas Counts now!

#### AND NOW FOR A WORD...

There are two changes to be made from last month's Christmas Count announcements. Barry Sauppe's work schedule this year will not permit him the time to do the actual compiling, so I once again agreed to give it a try. Barry, along with Peter Metropulos, will be able to do some intensive scouting in the weeks before the counts and he'll be able to give us his expertise for more than half of one count day and (hopefully) all of the other. As coordinator, Peter will do the bulk of the work in assigning areas and teams. The real birding work will be in the hands of the experts so the compiler will be doing mostly the after-count bookkeeping.

Traditionally, after each count we get together for some hot food and for a preliminary species count of the birds seen. We will be continuing this tradition after the Crystal Springs Count but, because the Afto Nuevo count is on New Year's Eve day, we'll be foregoing that compilation. Area leaders will receive information on where and how to turn in their count results with their area assignments. Next year we plan on going back to the two compilations.

At our October Board of Directors' Me ing ACR elected officers, directors and advisors for the coming year. The sponsoring Audubon chapters continue to provide vital leadership roles for ACR. New president Jack Harper (the past president of Madrone) and first vice president Gary Holloway (past president of Marin) are only two of the many chapter representatives involved with the Ranch. New board members include Art Feinstein, Cliff Richer and Tom White. New members on the Advisory Board are Katie Beacock, Susie Coleman and Sue Hossfeld.

Our energetic docents remain the life blood of the ACR environmental education programs. The Bouverie Audubon Council informs us that its 96 docents worked with 2557 children and 1282 adults during the past year. This includes those who attended guided walks, talks, seminars, workshops and special events. Bouverie Preserve biologist John Petersen announced publication of two new books prepared especially for docent training in Sonoma. At the Ranch, the ACR Volunteer Council's 68 docents guided 3526 children from 109 schools through their program which includes uncounted school visits. They updated their fall teaching manual and renovated the teaching kits they bring to schools around the Bay Area.

Plans are being made to develop tra on both the east and west shores of Tomales Bay. Both may pass adjacent to or through ACR preserves. Aquaculture leases are also being made there by the State Department of Fish and Game. biologists and the Properties and Conservation Committee continues to evaluate the role we will play in both developments.

There is still time to make your tax deductible contribution to ACR this year. Your gift of \$5 will enable us to send you ACR bulletins. Donors of \$100 or more are invited to our annual thank you party at an ACR preserve. Of course this annual appeal is a major fund raiser for operations, maintenance and programs at various Ranch preserves.

great blue heron quietly works the se of the lily pads lining the shore of a small pond. The bird's every movement is slow, precise, calculated. It peers into the water with singular diligence. A light breeze ripples the pond's surface, breaking up the images below into a jumble of colors and reflections; the heron concentrates even more carefully, searching for a telltale flash, a dark, drifting shape.

The fish, a small bass, is of moderate size, perhaps three or four years old. It is unaware of the heron as it swims placidly along the boundary between the shelter of the lily pads and the danger of the open water.

The heron first sees the fish when it is well outside of striking range. Its undulating fins reflect the sunlight in characteristic patterns. The heron is not concerned with the identity of the fish, but senses only that this object in the water will fulfill its need for food.

The heron waits patiently for the fish to come closer. Watching. Slowly, imperceptibly, it turns its head for a better view. Waiting.

The heron prepares to strike. Ever so slowly, it retracts its head, storing explosive energy in its coiled neck. ery muscle in its body tenses; all fort is directed towards the single goal. Below the water's surface, the heron's long toes firmly grip the algae covered rocks, bracing the bird against the imminent recoil. Anxiously waiting.

A gust lifts a plume from the heron's neck. The shadow of the feather falls across the fish's eye. Startled, it darts for the safety of the lily pads. Waiting. The heron begins to relax, but the fish returns almost immediately, and the vigil continues. Carefully watching.

When the precise moment to strike arrives, the heron will know. When its prey has reached the perfect position, when the probability of a miss falls to near zero. Meanwhile, there is nothing to do but watch. And wait.

The fish inches closer. The hunter, the hunted. Patiently waiting. One heron, one fish; all else fades away. Silently waiting.

Ever closer. Waiting. Closer still. Waiting. How near must the fish come? Waiting. The fish pauses, begins to turn away. Watching. Waiting. NOW!

Once again, because of work-scheduling problems Cliff Richer has to step in and compile both counts. Barry Sauppe and Peter Metropulos will scout out the areas but we need even more help than usual to follow up on the scouting. In order to do our best we need a lot of people. We need all the eyes and ears we can get to find birds, keep records in the field, and count birds. Christmas Counts mean dawn-to-dusk birding, plus owling for some. We need people who will walk city residential areas, school grounds, golf courses, parks and cemeteries within both count circles and report the population of each species they find. #### FIELD TRIP REPORTS

#### JANET DUERR

HAYWARD SHORELINE: Tuesday, October 25

A small but select group joined leader Nick Coiro for a midweek trip to Hayward Shoreline. Those who braved the terrible traffic across the San Mateo bridge were rewarded with beautiful weather and the wide open spaces of the newly accessible shoreline park. A number of different waterfowl species were seen, although they were not yet in great numbers, as well as several species of shorebirds. The highlights of the trip included a passing peregrine falcon and good looks at the unusual stilt sandpiper. This park, not visited frequently by those of us on the peninsula, is definitely worth visiting in future field trips.

SAN BRUNO MOUNTAIN: Saturday, October 29

Leader Al Seubert was joined by 13 members of Sequoia Audubon for a trip on San Bruno Mountain. Although this mountain looks very bleak to those of us driving by on the freeway, the north side is green and relatively undisturbed. The birds were relatively scarce this late in the fall, so Al, who is very familiar with this mountain at all seasons, turned the morning into a general nature hike. Everybody made it up to the top of the mountain, where they were rewarded by great views of the Bay Area. Al will be repeating this trip next spring, when the scenic views will be supplemented by wildflowers and more species of birds. (Note: Two of the field trip participants took the Editor aside to tell him how much they enjoyed the field trip, because it was different and because Al Seubert showed both his knowledge and love of San Bruno Mountain. ---Editor)

PALO ALTO BAYLANDS: Saturday, November 5

Twelve members and three guests joined Steve Schafer for a morning in this park along the edge of San Francisco Bay. As usual, the ducks and gulls in the small duck pond were not at all shy, allowing many close-up views. While some members examined the 10 species of waterfowl, others challenged themselves with trying to separate the different plumages of six species of gulls. Highlights of the trip included an American Bittern in full view, discovered by a visitor on her first birding trip, and glances at several Virginia Rails, mostly skulking in the pickleweed, but including one which flew across a small channel, legs dangling. The tides were not high enough to chase out any lurking Clapper Rails, but it was great to be out in the warm, sunny weather with friends and 53 species of birds.

ANO NUEVO: Saturday, October 25

Leader Gary Strachan made a last minute change in the scheduled field trip by substituting Ano Nuevo for Cascade Ranch. The change was dictated by an overnight rain that turned the Cascade Ranch roads and trails into mud. The twenty-three participants were not short-changed however as they were rewarded by a view of a captured San Francisco Garter Snake (to be identified, tagged and released.) The highlight birds of the trip were a distant marbled murrelet, a palm warbler, good views of a male harlequin duck and several pectoral sandpipers.

## TOXIC METAL POLLUTION AND MARSH CONVERSION IN THE SOUTH BAY

In 1975 the Regional Water Quality Control Board ordered that municipal sewage treatment plants could no longer discharge their effluent into the Bay south of the Dumbarton Bridge. The three water treatment plants, which are run by the cities of Palo Alto, San Jose, Santa Clara and Sunnyvale asked for a temporary exemption to this rule in order to study the situation. Working together as the South Bay Dischargers' Authority (SBDA), they recently completed a 5 year study which claims that their discharges really provide a net environmental benefit to the Bay. They are now requesting a permanent exemption from the RWQCB's prohibition against dumping treated water into the South Bay.

The Peninsula Conservation Center, Citizens for a Better Environment (CBE), Save San Francisco Bay Association, Santa Clara Valley Audubon, Sierra Club and other groups have joined a coalition called CLEAN (Coalition for Effluent Action Now) to express concerns about the effect of granting an unconditional permit for continued discharges into the South Bay.

There are two major concerns about SBDA's discharges: toxic metal pollution and marsh conversion.

The treated effluent water contains heavy metals (cadmium, chrome, copper, lead, nickel, silver and zinc) which then become even more concentrated in South Bay water and mud. SBDA proposes no solution to this problem even though it anticipates a 25% increase in such discharges by 1995. CLEAN is suggesting that significant reductions can be accomplished by removing metals before they are put into the sewage pipes. Continuing to allow heavy metals into the marshes can result in sick and dying wildlife from heavy metal poisoning.

Salt marshes at the point of discharge have been converted to brackish marshes. Salt marsh is being encroached upon daily by development. Increased fresh water in the marshes is also changing the habitat and excluding salt marsh dependent species such as the endangered California clapper rail and the salt marsh harvest mouse. Counts of clapper rails have shown a drastic reduction in recent years, particularly in areas near the treatment plant outflows.

CLEAN is asking that we write to the Regional Water Quality Control Board with the following points:

- The board should set enforceable standards for heavy metals and other toxins being discharged into the Bay. These standards should set maximums not only for allowable concentrations, but also for net amounts of pollutants.
- 2. These discharge standards should at least match the standards for discharges into the ocean adopted by the State Water Ouglity Control Board
- Quality Control Board.

  3. The treatment plants should set up a toxics reduction audit program to monitor the discharges entering the system.

4. The SBDA should provide mitigation or restore converted salt marshes in order to provide habitat for the clapper rail and the salt marsh harvest mouse.

#### RIP-RAPPING THE BAYSHORE

It seems that at each monthly meeting of the Conservation Committee we are asked to comment on requests for permits from the Corps of Engineers for restaurants and other bay front owners to riprap (place large rocks) along their bayfront properties to prevent erosion. This month we were asked to comment on plans to rip-rap along the bay between Beni Hana's and Charlie Brown's in Burlingame. The Department of Fish and Game called us specifically to ask our comments on this. The rip-rap would be 40 feet long and 5 feet wide destroying yet another small strip of habitat for bay-dependent wildlife.

Members of the Conservation Committee went to the site in question and reviewed the plans for riprapping. The current plans would complete a biking path and walking path in the area but some marsh area would be destroyed by the riprapping. This tiny marsh is home to clapper rails which have been seen here on several Christmas Counts. We are suggesting that the plans be amended to protect the marsh.

#### MONO LAKE SCENIC AREA DRAFT MANAGEMENT PLAN

The National Forest Service has released the draft plan and environmental impact statement for the management of the Mono Basin National Forest Scenic Area. The plan includes several alternatives. The Conservation Committee is reviewing the plan and will let the Forest Service know our views. If you would also like to comment, send your request for a copy of the plan summary document to:

#### BELMONT SLOUGH DEVELOPMENT

A private developer who own 20 acres of land at the mouth of Belmont Slough has plans to build 144 condominiums and possibly a marina at that site. Currently there are no other developments on that side of Foster City Boulevard. This parcel had been included in the plans for the Foster City Marina which was turned down last spring. Friends of Foster City, a local group which was instrumental in opposing those plans, intends to be active in opposing any development along this part of Belmont Slough. This site is adjacent to a wildlife preserve where least terns, clapper rails and other less endangered species breed.

The "Call for Information " period has begun for offshore oil drill ing on Lease Sale #119 which includes the area from Monterey to Sonoma County. Please write now to the Minerals Management Service by Jab 3. and tell them you are opposed to any lease sales off of the Central California coast. Your comments can include personal observations and values. At particular risk from off shore oil drilling is the Farallons National Marine Sanctuary and Ano Nuevo State Reserve. The probability of a large oil spill is 99%. California's entire undeveloped coastal shelf holds a mere 35 to 77 days worth of oil. Each platform will produce up to 150,000 tons of toxic drilling wastes. Please address your comments to:

DRAFT MONO BASIN NATIONAL FOREST SCENIC AREA PLAN

YOUR COMMENTS NEEDED BY JANUARY 19

The U.S. Forest Service has just released a draft Comprehensive Management Plan and Environmental Impact Statement for the Mono Basin National Forest Scenic Area that, if strengthened and enforced, could lead to permanent protection for Mono Lake and the millions of migratory waterbirds that depend upon it for survival.

In a LANDMARK DECISION, the Forest Service proposed <u>keeping Mono Lake at a water level which protects</u> the lake's sensitive and unique ecological balance and which lessens the risk of toxic air pollution caused by dust storms arising from Mono's exposed alkali lakebed.

The Forest Service pledged to take an active role in efforts to find water and power sources to replace Mono Basin diversions and to develop strategies and actions for ensuring that Mono Lake is maintained at the recommended water level. The Forest Service also stated that it would continue to "negotiate with public utility entities and other affected parties" to return water to portions of the following de-watered streams: Rush, Lee Vining, Mill and Wilson creeks.

The most important action you can take this year for Mono Lake is to comment on the draft management plan.

The Mono Lake Committee prepared the following recommendations which are also endorsed by National Audubon.

#### THE CHALLENGE FOR THE SCENIC AREA

The Scenic Area must somehow accommodate increasing numbers of visitors without sacrificing the qualities that brought them. These qualities include not only the pristine natural landscape with its abundant wildlife, but also the solitude of remote beaches and tufa groves, volcanoes and ridge tops.

While interpretation is an important educational tool,  $\underline{\text{it}}$  should not be emphasized at the expense of sensitive natural values. Nor should it ruin the rich opportunities in the Scenic Area for discovery and exploration through extensive development of roads and visitor services.

#### ANALYSIS BY ALTERNATIVE

The Forest Service looked at a range of alternative management programs (and lake levels):

- AMN (Amenities): Emphasize the protection and enhancement of wildlife, habitat and visual resources while continuing a moderate level of recreational opportunities (lake level range: 6390-6380).
- <u>CUR</u> (Current): Current management direction; i.e. would continue existing programs and facilities (this is the no action alternative) (lake level range: 6385-6372);
- <u>DEV</u> (Development): Emphasize developed recreational and interpretive facilities and opportunities; i.e., extensive campground and day use facilities (lake level range: 6390-6384);
- INT (Interpretive): Emphasize interpretive facilities, wildlife
  and visual values (lake level range: 6390-6377).
- PRO (Protection): Allow natural processes to shape and form Scenic Area but does not include enhancement of wildlife and vegetation resources (lake level range: 6390-6370).

While the Forest Service has selected INT as its preferred alternative, the Mono Lake Committee believes that the AMN ALTERNATIVE should be adopted because it adheres more truly to the legislative mandate of providing protection for the "scenic, geologic, ecologic and cultural resources" of the Scenic Area, while providing for scientific research activities and recreational and traditional uses.

Your letter is urgently needed to support the Forest Service's position on Mono Lake water levels as well as to request that the Forest Service adopt the Amenities Alternative as its preferred management policy. #### BIRDING SAN MATEO COUNTY

#### Peter Metropulos

to 10 PIMKFOOTED and 4 BULLER'S SHEARWATERS were studied from shore at Pescadero Beach on October 6 (AK.RT)

An AMERICAN BITTERN preening in the sunshine among rushes at Affo Nuevo Point pond on October 8 (PM) and feeding at the same location on October 25 (GS, mob) were the only reports of this species. A GREEN-BACKED HERON flushed from Laguna Salada in Pacifica on October 9 (PM) was the only report.

A GREATER WHITE-FRONTED GOOSE was at Pescadero Marsh on October 22 (RT). They occur sparingly along the coast in late fall and winter. A female BLUE-WINGED TEAL was with other drab dabblers (drabblers?) on a ranch stock pond south of Half Moon Bay on October 15 (PM). A drake HARLEQUINDUCK returned to its usual wintering haunts in the rocky coves of Affo Nuevo Point October 8 (PM). The first HOODED MERGANSERS to be found were 4 at Pescadero Marsh on October 30 (SF) and one at Redwood Shores (JB) on October 31.

A ROUGH-LEGGED HAVK was hunting at Pescadero Marsh (Opening Day of Rodent Season), October 30 (RT). A FERRUGIMOUS HAVK perched on buildings and on the runways of the Half Moon Bay Airport from October 20 to 23 (AK, PM).

Four LRSSER GOLDEN-PLOVERS were reported from their usual ocean-shore locations at Affo Nuevo and Pigeon Point.

Both POMARINE and PARASITIC JAEGERS were observed at Pescadero Beach October 6 (AK,RT) attracted to ocks of feeding shearwaters and other sea-birds lose to shore.

A lone BURROWING OWL at the Redwood City baylands on October 23 (GSm) is one of a mere handful remaining in the rapidly disappearing County baylands. SAW-WHET OWLS were back calling on their winter territories at Canyon Road near Pescadero (RF) and El Granada (BS) during mid-October.

A late migrant VAUX'S SVIFT zoomed south along the coast at Moss Beach on October 1 (DK).

A MUTTALL'S WOODPECKER wandered to Laurelwood Park, San Mateo on October 26 (AK). This species is resident in white oak woodlands from San Carlos south, and is a rare straggler elsewhere in our County. A PILEATED WOODPECKER continued to be heard hammering and calling along Canyon Road east of Pescadero through October (RF).

Following several local reports last month, a single TROPICAL KIMGBIRD was found at Princeton Harbor on October 4 (DK) and two were seen together at the nearby Half Moon Bay airport on October 20 (AK, PM).

The only RED-BREASTED MUTHATCH reported this month was in a Burlingame yard on October 30 (AK).

A BLUE-GRAY GWATCATCHER flocking with bushtits in willows at Half Moon Bay airport from October 20 to 30 (PM) may be a bird which will winter in our area.

TENNESSEE VARBLER was part of a massive warbler lock at Pescadero Creek on October 15 (PM). With

only one previous County record, the VIRGINIA'S WARBLER at Pescadero Creek on October 10 and 11 (RT.DK) was of special interest. A flashy WAGWOLIA WARBLER joined the flock of migrants at Pescadero Creek October 15 (PM). An elusive dull-colored warbler feeding alone in the willows at Princeton Harbor on October 1 turned out to be a female BLACK-THROATED BLUE WARBLER (DK). a BLACKBURWIAN WARBLER flocking with a group of Townsend's warblers at Pescadero Creek on October 15 (PM) was the first of this species seen along our coast in several years. Ten PALM WARBLERS were detected among coastal willow thickets and open fields from Afto Nuevo Point to Half Moon Bay this month. Another of the "vagrant" warblers occurring in small numbers each fall, single BLACKPOLL WARBLERS were observed as follows: Moss Beach, Oct. 2-3 (DK, PM); and different individuals at Pescadero Creek, Oct. 6 and 22 (RT) and on Oct. 15 (PM). An adult male AMERICAN REDSTART at Pescadero Creek on October 29 (RT) was suspected of being the bird that wintered here last year. A very late MAC GILLIVRAY'S WARBLER at Princeton Harbor from October 30 through November 4 (PM, AK) may be trying to winter locally.

A "vagrant" sparrow occurring with some regularity each fall, a CLAY-COLORRD SPARROW was at the Half Moon Bay Airport on October 18 (PM). Even rarer for San Mateo County, was a BREWER'S SPARROW at the same location on October 11 (PM). Extremely secretive and seldom detected during migration, a GRASSHOPPER SPARROW was also at the Half Moon Bay Airport on October 11 (PM). The first SWANP SPARROW of the fall was at Moss Beach on October 3 (PM) and two more were at Pescadero Creek on October 23 to 29 (RT). A WHITE-THROATED SPARROW at Pedro Valley Park (JS) was the only one reported.

A LAPLAND LONGSPUR was along the trail at Año Nuevo Pt., Oct. 8 and two were flushed from stubble at the Half Moon Bay Airport on Oct. 11 (PM). Even more exciting were three hard-to-get-a-look-at CHESTNUT-COLLARED LONGSPURS at the Half Moon Bay Airport on October 23-24 (PM, RT).

Close-up scrutiny of a 2000 bird blackbird flock at the Half Moon Bay Airport on October 30 yielded pone YELLOW-HEADED BLACKBIRD, a very rare bird in our region (PM).

The only RKD CROSSBILL reported this month was a lone bird at El Granada on October 8 (BS).

#### OFFICIAL RULES

Counts must be made during a single calendar day within the official Christmas Bird Count period.

Counts of fewer than 8 hours will not be accepted.

The count area must be within the designated 15 mile circle.

Separate records must be kept for feeder-watchers, owling parties and regular field parties.

Separate records must be kept for miles traveled by different means of transportation (foot, auto. bike, boat, etc.)

The \$4.00 fee is required from each participant. Otherwise the participant will not be listed and his/her birds will not be counted. Feederwatchers do not have to pay the fee unless they want to be listed in American Birds. Then they should pay the fee.

#### COMPILER'S EXPLANATION

Makes sense to me.

This applies to the count itself, not to individual participation. We need your help even for half a day.

Last year we had two well-meaning last minute participants who decided to "free-lance" at some of their favorite birding areas - only one of which was within the count circle! Be sure your efforts won't be wasted.

Don't keep separate records for the birds, but do keep track of the hours, whether the party splits up into smaller parties, the miles traveled, etc. Recording the birds is easy, this part is the compiler's proverbial posterior pain, so PLEASE, PLEASE, fill out the bottom of the form.

In order to be sure that you'll be listed in American Birds, send your money in to Sunny at the office. On count day the leaders and compiler are tired and/or excited and it's easy to lose track of who paid and who didn't.
