THIS MONTH'S PROGRAM

Our December potluck meeting will begin with a 15 minute slide presentation by Dr. William Tuohy of the San Francisco Estuary Program. This five year Environmental Protection Agency program is designed to promote effective management of our bays and the Delta. Dr. Tuchy will briefly discuss some of the current environmental issues that confront the estuary, ongoing projects concerning our waterways, and how we can become involved in the project.

month's main presentation will introduce us to the mysterious mountain island in the Sacramento Valley, the Sutter Buttes. Don Schmoldt is a wildlife biologist and former coordinator of the Sutter Buttes Naturalist Program (a program developed by Walt Anderson). He I share the wonders and mysteries of t was to the Maidu Indians the center of the world. Our journey into the private lands of Sutter Buttes will reveal the unique geological origin and the flora and fauna resulting from 10,000 years of isolation. We will also visit the state and federal wildlife refuges which flank the buttes. Each winter, these refuges offer a haven to millions of ducks, geese, and swans. It is here that we can still take part in the breathtaking experience of seeing tens of thousands of waterfowl filling the air, one of the truly great wildlife spectacles of the world.

JANUARY'S PROGRAM

John Silliman, frequent world traveler, as well as former president of Sequoia Audubon, has consented to stay home long enough to share with us his experiences during his recent trip to the Galapagos.

Because of their isolated location the Galapagos Islands have developed their own distinct ecosystem. It was Charles Darwin's study of the Galapagos' finches that led to the theory of evolution.

Today the islands are an ecological preserve with restricted access and strict environmental protections.

Currently, SAS has been working on some fundraisers. bird seed sale was successful as we sold over \$1,000.00 worth of seed and netted about \$300.00 for the chapter. We wish to thank Santa Clara Valley Audubon Society generously allowing us to pool our bird seed orders with theirs to ensure a larger profit for us. By the time you read this the Wild Goose Chase will be over. I hope all of you supported it.

The Christmas Bird Counts are coming right up. The Crystal Springs Count is on December 16 and the Affo Nuevo Count is on December 30. I highly recommend the Christmas count experience. I have participated in these counts for the last three years and found the experience rewarding. We don't often go out to count every bird we see and it makes for a different type of experience. It forces you to try to see every bird equally. I will never forget the hundreds of migrating robins I saw last year in Big Basin, and the immature peregrine falcon I spotted high on a redwood tree in Big Basin the same year. Then there was the prairie falcon and pileated woodpecker we spotted last year in the Crystal Springs watershed. The funnest part of Christmas count is the compilation dinners, where you get to meet with all the other birders, hear their stories of the day, and find out just how well the count went. Remember, it doesn't matter what your level of expertise, we can find something useful for you to do.

A few years ago a young lady burst onto the Sequoia Audubon scene. Suddenly it seemed she was everywhere. She threw wholeheartedly into the tasks she undertook. And herself once in a while she would offer suggestions. More and more we found ourselves listening to and following them. It didn't take long for us to realize we had a future SAS president in the making. Now President Gail Smithson is moving on, to continue growing. She takes with her our best wishes and our confidence in her future.

Since ACR is a bit out of the way for many of us, why not make a day of 1t? Plan to spend Saturday, December 9 exploring Marin and shopping at ACR. Be sure to pack a special picnic lunch and leave early so you can enjoy the entire day. From Hwy. 101 take the Hwy. 1 Mill Valley exit. Follow the signs to Muir Woods where a winter walk in the redwoods is especially dramatic, and who knows, maybe you will be lucky enough to see the steelhead migrate up the creek as you meander along the path. From Muir Woods return to Hwy. 1 and continue north past the town of Stinson Beach to Bolinas Lagoon. Make several stops along the way to see the many ducks, waders and shorebirds which winter here. Be sure to watch for harbor seals which may pull out near the road.

About 3 miles north of Stinson Beach stop at ACR. Check the bird blind for landbirds, check out Zumwalt Gallery, picnic in the Ranch yard and don't forget that very special Christmas shopping in the Bookstore.

From the ranch, continue north toward Pt. Reyes National Seashore. When you get to Five Brooks turn left and drive up the dirt road to the parking area. Walk out to the pond where you have a better than even chance of seeing a wood duck or a hooded merganser. The walk around the pond is less than a mile, the (Continued on Page Three)

A few miles north of Five Brooks is the headquarters of the Point Reyes National Seashore at Olema. Be sure to spend a few minutes in the very attractive visitor's center. Perhaps this is the year you should walk the half-mile Earthquake Trail --- perhaps it isn't.

You can return east to Hwy. 101 on Sir Francis Drake Boulevard or continue north on Hwy. 1. If your trip begins to the north, you can just as easily reverse the course described here.

JAN.20-21 LOS BANOS REFUGES AND PANOCHE VALLEY FIELD TRIP. SATURDAY This trip covers 2 very diverse areas and exposes SUNDAY us to a variety of rare and unusual birds. The four refuges north of Los Banos are noted for white-faced ibis, sandhill cranes, a large variety of waterfowl and shore birds, raptors and owls. Twenty miles south of Los Banos, Little Panoche Road winds its way through the Diablo Range into Panoche Valley where wintering flocks of mountain plovers, vesper sparrows, mountain bluebirds, long billed curlews, and perched raptors vie with the resident roadrunners, phainopeplas and chukars for the birders' attention. Saturday we plan on meeting in the parking lot of the Los Banos Wildlife Area on Henry Miller Road north of the town of Los Banos at 9:00 A.M. FIELD TRIP REPORTS

JANET DUERR

SAN BRUNO MOUNTAIN Saturday, 7 October 1989

Al Seubert led a group of nine adventurous souls on a natural history tour of San Bruno Mountain. In the morning, the group concentrated on birdwatching, and saw many of the area's year-round resident species. Some migrating warblers were also spotted in the wooded areas. After lunch, several of the group continued their hike to the top of the mountain, where they were rewarded with a panoramic view of the Bay Area.

SAN MATEO NORTH COAST Sunday, 8 October 1989

Five hardy birders joined Dan Keller, leading his first field trip for Sequoia Audubon, on a foray through his favorite coastal hotspots. The group saw numerous migrating and resident species, including most of the wrens. A palm warbler was the 'rarest' bird of the day, but two common birds, a Hutton's vireo and a ruby-crowned kinglet, stole the show by perching very near each other and providing an unusual side-by-side comparison. Dan was able to point out the subtle differences that distinguish these two species, which are often difficult to separate in the field.

MONTEREY COUNTY: Sunday, 15 October 1989

Steve Schafer led six Sequoia members on a loop through some of Monterey County's best fall birding areas. The effects of our prolonged drought were much in evidence, as both the pond at Zmudowski State Beach and the slop pond at Moon Glow Dairy (the leader's favorite Monterey birding locale) were both dry. Nevertheless, the group finished off the day with a healthy list of 85 species seen or heard. The highlights of the trip included common murres and rhinoceros auklets offshore at Zmudowski, and an extremely cooperative juvenal ruff. The ruff had been present on and off at the Salinas Sewage Ponds for several days, and was thoughtful enough to be 'on' while the group was there.

Peter Metropulos and Ron Thorn will also be helping with scouting before the count. In order to see the most birds we need lots of help. Even if you are a beginning birder or just like to get out in the open air we can use your help on a team to keep records in the field and count birds. Christmas counts mean dawn-to-dusk birding, plus owling for some. Even it you can only devote a few hours at a feeder or in a local park, we need your help. We need people who will walk city residential areas, school grounds, golf courses, parks and cemeteries within both count circles and report the population of each species they find. The Christmas count is important because it gives us a good idea of trends in the populations of the birds in our area and can alert us to changes. The count results are reported in American Birds and also with Cornell Laboratory.

If you are unable to participate in the field, could you help out at home counting backyard birds or at the Garden Center preparing the hot meal for the hungry counters on December 16 and/or 30?

previous column dealt with the common (English) names of North American birds. This time, we'll look at their scientific names.

Every known living organism is given a two-part scientific name. These are based on Latin grammar, and are often called Latin names, even though many are derived from other languages, or from the names of persons or places.

The first part of a scientific name, the genus or generic name, classifies the organism into a group of one or more closely-related species. The second part of the name, the specific name, identifies a particular member of the genus in question. The generic name is always a noun, and is always capitalized, while the specific name is usually an adjective, and is never capitalized, even when it is derived from a proper name.

Two different species may have the same specific name, as long as their generic names are different. For example, we have Laterallus jamaicensis (Black Rail) and Buteo jamaicensis (Red-tailed Hawk). In both cases, jamaicensis refers to the site (Jamaica) where the first specimens were found. On the other hand, generic names are never duplicated; thus the name Buteo, which refers to the buzzards, or soaring hawks, cannot be used in any other context.

Because scientific names are often based on Latin or Greek roots, they can be difficult for an English-speaking person to remember. A good example is Coccyzus erythrophthalmus (Black-billed Cuckoo), which is impossible just to pronounce, let alone remember. Some birds, on the other hand, are easy. The Anhinga's scientific name is no problem at all; it's Anhinga anhinga. But beware of Ajaia ajaja, the Roseate Spoonbill. The generic and specific names look the same, but they aren't quite.

Who selects the scientific name for a newly discovered species? This privilege goes to the first person who publishes a paper describing the species. The rule of priority is strictly whoever describes a species first gets enforced: to choose the name. In addition, the name is used exactly as published, even if there are typographical or other errors. Thus we have Toxostoma dorsale (Crissal Thrasher), even though it was supposed to be Toxostoma crissale. The name dorsale came from a junco described in another paper in the same publication, and was accidentally substituted for crissale by a printer's error. Similar My, we have Dendroica pensylvanica (Chestnut-sided Warbler), even though Pennsylvania, where the species was first found, is spelled with two n's.

Frequently, scientific names have to be changed, usually as a result of new scientific data that shows that the generic relationships are different from what was previously believed. Whenever possible, only the generic name is changed, and the specific name is retained. Occasionally, name is changed because it has been discovered that the species had been described earlier than commonly believed, and the original author is then given priority. In some cases, a species may experience several name changes as new information A particularly messy example is

LeConte's Sparrow, whose various scientific names and the dates of their assignment are:

1790: Fringilla caudacuta 1843: Emberiza leconteii 1872: Coturniculus leconteii 1886: Ammodramus leconteii 1910: Fasserherbulus lecontei 1931: Passerherbulus caudacutus 1973: Ammospiza leconteii 1983: Ammodramus leconteii

The repeated flip-flop between caudacuta(us) lecontei(1) was the result of confusion about priority, and also conflict with the scientific name of the Sharp-tailed Sparrow (currently Ammodramus caudacutus).

One unusual species is Say's Phoebe (Sayornis saya). It is the only case where a person (Thomas Say in this case) has been honored in all three names, common, generic, and specific. Actually, when the bird was first described by Charles Bonaparte, it was placed in a different genus, and not until later was it merged into the genus Sayornis with the other phoebes. Another interesting pair is Otus asio (Eastern Screech-Owl) and Asio otus (Long-eared Owl). Asio is from a Latin word meaning a kind of owl, while otus is from the Greek and refers to the owls' ear tufts.

The history behind the names of birds can be fascinating. As before, most of the material in this column comes from the Dictionary of American Bird Names (revised edition), by Ernest A. Choate. I heartily recommend this book to anyone interested in birds, and how names, both common and scientific, are bestowed upon them.

A few American birders - usually those who als have scientific credentials as professional ornithologists - have been crusading for the use of scientific names. Most of their colleagues have greeted this call with profound apathy. However in Europe, particularly in Scandinavia, the use of scientific names by even casual birders is common. This eliminates the confusion created by a multiplicity of common names, language differences and local dialects.

MONO LAKE NEWS

The Mono Lake Committee's November newsletter is a gem, packing a wealth of information in its 24 pages. The last few months have seen a number of developments that may mean the 10+ year battle to save Mono Lake may be won and this newsletter has a joyous tone. If you're not a Mono Lake Committee member but you have the slightest interest in what happens to the lands east of the Sierras, you should join just for this newsletter. Some highlights from the newsletter:

Thanks to a court-ordered preliminary injunction the Los Angeles Department of Water and Power (DWP) has had to increase the flow of water down Rush Creek and into Mono Lake from a minimal 76 gallons per second to 720 gallons per second.

Nevertheless, Mono Lake's elevation is still dangerously low. At 6375 feet above sea level it is two feet below last year's level and only 6 inches above the level at which the landbridge connects with Negit Island. Two moderate dust storms have originated on the landbridge this fall and coyote tracks have been discovered on the island. National Audubon and the Mono Lake Committee are urging the court to expand its injunction to include Lee Vining, Parker and Walker Creeks in order to provide enough water to cover the landbridge and keep predators off the island before next year's nesting season.

In August the court also rejected DWP's argument that the lake be lowered another six feet in order to test whether any damage would be done to the environment. Patrick Flinn, an attorney for the National Audubon Society called the DWP plan "diagnosis by autopsy".

One of the means by which the DWP gained control of the Mono Lake watershed was through the purchase of most of the private land in the Mono Basin. Historically this land was over-grazed and DWP continued this trend by leasing it to sheep ranchers from throughout California. As a result antelope have been eliminated (although re-introduced in small numbers) and sage grouse seriously affected.

In April the Mayor and City Council of Los Angeles committed the city to a 10% reduction in water usage. The city was joined by the Mono Lake Committee and Heal the Bay, a group dedicated to saving Santa Monica Bay in urging conservation. Although water use was reduced only 4%, this objective was achieved despite a steady growth in LA's population. In August, the LA Board of Public Works created the Office of Water Reclamation. The office will try to market the reclaimed water to agricultural and industrial users and to recharge the underground aquifer.

The Mono Lake Committee also acknowledged that the Environmental Water Fund Bill sponsored by Philip Isenberg (D-Sacramento) and Bill Baker (R-Danville) provided the mechanism by which the lake could be saved and could free the Mono Lake Committee to move ahead on innovative solutions for the lake. The legislature also authorized the expenditure of \$750,000 for the study of Mono's streams and fisheries.

The newsletter also contains Part One of a two part article by Emilie Strauss and Lauren Davis detailing the history of the disastrous effects of fifty years of water diversions. The article also hints at a probable next objective for the Mono Lake Committee - an elevation of 6388 feet.

Another possible future job for the Mono Lake Committee is contained in the first of several articles on the "Great Basin Lakes of the Western Flyway". The article is authored by Elmer R. Rusco of the Friends of Pyramid Lake and gives a brief natural history of the lake and a synopsis of the environmental problems threatening its future.
