THIS MONTH'S PROGRAM

Doug Cheeseman will present the December potluck program on the natural history of Madagascar, a large island off the coast of Africa. Doug is biology professor at De Anza College, an active member of Santa Clara Audubon, and a leader for Cheeseman's Ecological Safaris. His tours and programs have long been favorites of Bay Area Audubon members.

Doug's program will examine the birds and mammals of this isolated island ecosystem. Madagascar has been declared a United Nations "Critical Habitat," and Doug's program will highlight some of the reasons for this designation. Doug will show slides of some of the 103 endemic bird species seen by his group. He will discuss some interesting behaviors of a group of dominant mammals on the island, the lemurs. (The group saw 14 of the 24 species of lemurs on their Madagascar trip.) He will also touch on the local flora, and some interesting behavior of the island's chameleons. Finally, he will include some photos and discussion of the people and culture of the island. Please join us for a full evening of entertainment including the potluck dinner and Doug's diverse program.

FROM THE PRESIDENT

The November issue of the *NEEDLES* went to press before we learned of the untimely death, from a heart attack, of our SAS Board Member David Moon. David joined the Board last June and his enthusiasm in serving as Chairman of the Fund Raising Committee and his involvement at Conservation Committee meetings was infectious and exemplary to all of us. His sudden death is a severe loss to all who were closely associated with him. Our deepest sympathies and condolences go to his beloved wife, Pat, who has asked that any bequests in his memory be made to SAS.

Audubon is a co-sponsor with the California Department of Fish and Game and the California Department of Education in introducing an exciting new environmental program for schools. Briefly, in the new California Endangered Species Education Program, the students will:

* identify endangered species of plants and animals in nearby habitats:

* adopt a local endangered species:

* research the threats to its habitat with assistance from local resource groups:

* design a plan to educate the community about the threats to the endangered species habitat:

* prepare a plan to save the habitat with community assistance.

Begin to plan for the National Audubon Convention, to be held in Estes Park, Colorado, July 21-23, 1991. The theme is to be "Audubon and the Americas", focusing on the relationship between people and wetlands, forests and wildlife in the Western Hemisphere. Ted Turner, founder of Turner Broadcasting Systems has been invited to attend. Audubon chapters in North, Central and South America will participate in the program and bring exhibits. Colorado chapters will arrange tours and field trips. the registration brochure and other program details will be distributed in January.

Dan Taylor, our Western Regional Representative, has sent out a special letter to remind us that Mono Lake, a national treasure where millions of birds feed during their breeding and migratory seasons is still battling to prevent diversion of its waters by the Los Angeles Department of Water and Power. Through the combined efforts of the NAS and the Mono Lake Committee, the fight is nearing victory. But more needs to be done to keep Mono Lake alive. Contributions to the National Audubon Society Keen Mono Lake Alive Fund are necessary to continue the legal battle. Your donation will help preserve this unique California landmark.

It was a pleasure, such as I have not had in a long time, to go on the Elkhorn Slough field trip led by Steve Schafer and Janet Duerr. with the approaching holidays there will be similar opportunities for members to enjoy the pleasure of being with friends and sharing new birding experiences. One of the most exciting and rewarding of these experiences will be the 92nd Annual Christmas Bird Count. WEDNESDAY, JANUARY 16 PRINCETON HARBOR FIELD TRIP

The only sheltered harbor between Santa Cruz and San Francisco, Princeton Harbor is winter home to a good variety of bay ducks, loons, cormorants and other divers as well as gulls and shorebirds. Not only does the harbor usually have one or two surprises, but the nearby willows, cypresses and grasslands have proven to be first-rate warbler traps. Clay-colored sparrows, palm and prairie warblers are only a few of the species that have wintered here the last few years. To get there take Hwy. 92 to Hwy. 1 and follow Hwy. 1 north to Capistrano Rd. and turn left at the lights. Take your first left and proceed straight ahead into the upper parking lot where we will meet at 9:00 A.M. This will be a walking trip along the beach and rocks with some areas of broken footing, so boots or sturdy shoes are recommended. The trip should break up at noon. LEADER: Nick Coiro (349-1834)

SATURDAY, JANUARY 26 PESCADERO MARSH FIELD TRIP

FEBRUARY

SATURDAY, FEBRUARY 2 THE LOS BAÑOS WILDLIFE AREA AND THE GRASSLAND REFUGES SUNDAY, FEBRUARY 3 PANOCHE VALLEY

One of our highlight field trips of the year covering two diverse areas and exposing us to a variety of rare and unusual birds. On Saturday we will explore the four refuges north of Los Baños where we will look for whitefaced ibis, sandhill cranes, a large variety of waterfowl and shore birds, raptors and owls. We plan on meeting in the parking lot of the Los Baños Wildlife Area on Henry Miller Road north of the town of Los Baños at 9:00 A.M. On Sunday we will go twenty miles south of Los Baños to where Little Panoche Road winds its way through the Diablo Range into Panoche Valley. Wintering flocks of mountain plovers, vesper sparrows, mountain bluebirds and long billed curlews as well as perched raptors vie with the resident roadrunners, phainopeplas and chukars for the birders' attention. CHUTZPAH!

Chutzpah is an almost untranslatable Yiddish word that is usually defined by using an example. The most commonly used example of chutzpah is that of the boy who kills his parents and throws himself on the mercy of the court because he is an orphan.

Exxon now threatens to redefine the term. It has filed claims against the US Coast Guard claiming that the Coast Guard is "wholly or partially responsible" for the Exxon Valdez oil spill. One of its claims is that the Coast Guard was negligent in granting licenses to the crew and officers of the Exxon Valdez!

N.P.S. MUZZLES YOSEMITE ASSOCIATION

The Yosemite Association, many of whose members and officers had been critical of the direction of the park's administration, was advised by the National Park Service that it was in violation of its charter. Under the NPS's interpretation, any independent comment on the Park - whether favorable or not - is forbidden.

Ridiculous? Short-sighted? Yes, but it's a familiar story to the former officers and directors of the Año Nuevo and Pescadero Interpretive Associations. Increasingly, park managers - at all levels - have come to the conclusion that cooperating associations should be seen and not heard. Docile docents, benign booksellers and faithful fund-raisers are the park managers' goals. Above all the park manager must avoid any semblance of criticism or dissent - no matter how bland. Most frightening to some of us is an increasingly prevalent attitude that they - the professional managers - are the real owners of the parks and the public users are merely nuisances with which they have to contend.

At first it appeared that the Yosemite Association would quietly fall into line. Its directors didn't even inform their members of the "muzzling" for more than four months.

But Yosemite is not Año Nuevo or Pescadero. A new non-profit corporation called the Yosemite Restoration Trust has come into being. Unlike the Yosemite Association the trust has no connection or standing with the Park Service. What it does have is an impressive board of directors and some well-heeled and politically connected sponsors. George Frampton, President of the Wilderness Society; Robert Binnewies, former Superintendent of Yosemite; former Secretary of Defense Robert McNamara; former Parks Service Regional Director Howard Chapman and Richard Goldman, founder of the Goldman Environmental Awards are all officers of the new corporation.

The Trust intends to become involved in the upcoming negotiation of the concessionaire's contract at Yosemite. The Curry Corporation has held the franchise for many years. Besides returning less than 1% of its \$85 million in park revenues, Curry has been accused of advocating more commercialization of the Valley floor and is regarded as being the prime stumbling block in implementing plans to reduce congestion and pollution in the Valley.

"The Curry Company knows how to run a good resort," said William Alsup, one of the directors of the Trust, "Yosemite is not supposed to be a resort."

One of the more bizarre developments in the Yosemite story arises out of the potential purchase of MCA, Curry's parent company, by a Japanese firm. News of this prompted the head of the Park Service to call the President of MCA and "suggest" that MCA not wait for contract negotiations but sell its National Park concessions to the Restoration Trust immediately. While we deplore the implied ethnocentricity of this call, we applaud the additional muscle it brings to the effort to restore Yosemite to the people.

Even if the Trust is unsuccessful in changing the role of the concession company at Yosemite, its creation should be regarded as a major step in returning the control of our parks to those who love them and have paid for them.

FIELD TRIP REPORTS

REDWOOD REGIONAL PARK

Sunday, October 7

The morning started out surprisingly chilly, but the bright sun and the birds quickly warmed leader Steve Schafer and twelve others on Sequoia's first trip to this East Bay locale. Unbeknownst to the organizers, a 'Redwood Fair' had been scheduled for the very same day, so the birders had lots of company. In spite of the bustling activity, about fifty species of birds were seen. The Redwood Fair did have its benefitsthere was plenty of good food for lunch.

MONTEREY COUNTY

Sunday, October 14

Seven hardy birders joined Steve Schafer on a cool, foggy morning in northern Monterey County. The reported Sharptailed Sandpiper at Moon Glow Dairy didn't show, but a Burrowing Owl put on an admirable performance in its place. We watched an American Bittern take a long, leisurely flight over Moss Landing Wildlife Area as we ate lunch, and yellowlegs of both persuasions were to be found along the upper reaches of Elkhorn Slough. All in all, 97 species (not including seals and sea otters) were seen.

HAYWARD REGIONAL SHORELINE

Tuesday, October 23

Three birders joined Linda Kypta, substituting for scheduled leader Nick Coiro, on a romp through the wetlands at the cast end of that long, skinny bridge. A Eurasian Wigeon put in a cameo appearance, as if to underscore the fact that the waterfowl have returned. Not to be outdone, a Peregrine Falcon also made its presence known. Fifty-two species of birds were seen altogether.

MONO LAKE UPDATE

In mid-August Mono Lake stood at 6376 feet above sea level. This is still 1.5 feet below the court-mandated level and continues to drop despite court orders that require the Los Angeles Department of Water and Power to continue the flow of water down Rush and Lee Vining Creeks.

Despite some cheating and outright defiance of the court orders by the DWP, the drought is the main reason for the lake's dropping water level.

In October, Judge Terrence Finney ordered the DWP to begin fresh water flows down Parker and Walker Creeks which had been dry since 1941. While insufficient to reverse the lowering of the lake, the new flows will help slow the rate of loss until seasonal rains and snow return to the area.

The DWP continues to fight all Mono Lake conservation measures. They have appealed the Mono Basin National Forest Area Comprehensive Management Plan and its Environmental Impact Statement, contending that the Forest Service's selection of a lake level range was a violation of DWP's rights. It is likely that their appeal will go to the Chief of Forest Service in Washington and that the DWP will lobby intensively to overturn the plan.

The DWP is also under fire for their treatment of the Owens River as a "channel of convenience" rather than as a natural resource. Critics contend that DPW's releases of water based solely on Los Angeles' water use requirements have caused collapsed stream banks and an incised stream channel.

Los Angeles mayor Tom Bradley recently appointed Mary Nichols to the DWP's Board of Directors. It is hoped that she will provide the crucial swing vote in favor of a more favorable environmental climate in the DWP.

Meanwhile the State Water Board, which was ordered by the courts in 1988 to review the Mono Lake situation, appears to be stalling in the hopes that someone else will decide he problem for them. They recently announced that they expect to come to a decision about the division of Mono Lake water sometime in 1992.

California gulls nesting on Negit Island remain mostly protected from coyote deprivation by a small channel and an electric fence although a few coyotes managed to get to the island in July. On Pancake Island however, the gulls abandoned 651 nests when coyotes waded across a narrow and shallow channel.

EPA DELAYS ANSWER

The Environmental Protection Agency has decided that it will not respond to a demand from several environmental groups that it intervene in the dispute over allocation of Bay-Delta waters. The EPA stated it would wait for the long-delayed state Delta salinity control plan before making any deisions.

The demand was served on behalf of a number of Bay Area complainants, including Sequoia Audubon. In the absence of a timely response the complainants may take their demand to the courts in the next step.

W'LIFE REHAB CLASSES

The Lindsay Museum in Walnut Creek is conducting two classes in wildlife rehabilitation.

Wildlife Care and Rehabilitation will be conducted on Saturday, December 1, from 10 AM to 4 PM. Fee is \$25 plus Museum membership. Bring a bag lunch.

Treatment of Oiled Birds will teach successful treatment techniques developed at the Lindsay Museum. Prerequisite is the above course. It will be conducted on Wednesday, January 23 from 7-9 PM. Fee is \$10.

THEY'RE HERE!

The first known migratory swarm of Africanized "killer" bees has crossed the border into the United States.

The swarm was trapped at Hidalgo in the Lower Rio Grande Valley of Texas and eraadicated by biologists from the U.S. Department of Agriculture.

Previous invasions of these bees have been confined to swarms that were inadvertent stowaways on ships or trucks from South or Central America. Last year's California incursion came from Mexico in a truckload of oil drilling casings. Prior attempts to stop their northward migration have met with total failure and there is little reason to believe that the US-Mexican border will be much of an obstacle to these aggressive intruders.

In all likelihood, we can expect the "killer" bees to join the ranks of the starling, the Japanese beetle, the fire ant and the eucalyptus as an undesirable alien.

BOOKS FOR BIRDERS

Some new books of interest to California birders are out or are in the works in time for Christmas. These are ideal for birders who need one more book about their favorite hobby.

Ocean Birds of the Nearshore Pacific by Rich Stallcup is every birder's guide to pelagic birding. It's 208 pages include sections on finding pelagic boat trips, seeing pelagic birds from shore and identifying common, rare and accidental species. Amply illustrated with black and white photos and drawings, it is a publication of the Point Reyes Bird Observatory.

Where Birders Go in Southern California by Henry Childs is a revision of an earlier edition of the book. It has capsule descriptions of scores of birding areas, 13 area maps and lots of helpful hints in its 190 spiral-bound pages.

An Introduction to Southern Californi Birds is a photographic overview of the region's birdlife. 252 photographs and a non-technical text.

A Birder's Guide to Southern California by Harold Holt is a rewrite of the popular Jim Lane guide. Holt and the American Birding Association have taken over the revision of the existing guides and the publication of new books in the series. Just off the presses, the book may not be generally available for one or two months. The new and completely rewritten Southern California guide has 248 pages and 60 maps.

JANUARY'S PROGRAM

Mike Rigney of the Coyote Creek Riparian Station will present our January program on the bird study and bird banding activities of the CCRS. Coyote Creek is located in Santa Clara county and is one of the few remaining riparian (streamside) areas without major flood control. The Coyote Creek banding station operates seven days a week, typically setting up 30-40 nets a day. The bird banders catch and release about 7-8,000 birds a year. Information collected by the volunteers at CCRS has provided important information on breeding and migrating birds in our area. CCRS banding data is also providing information on the importance of riparian areas, and the changes in the patterns of bird
