The other special big event will be the Birdathon during the last 2 weeks of April. Please use the form on page 3 to make a pledge or to form a team and join in this annual fund-raising event.

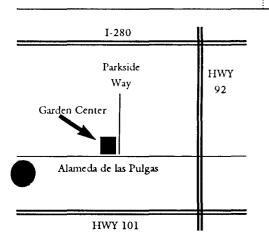
Ann Loper has volunteered to take on the job of Publicity chairperson. Aren't we fortunate to have so many people becoming involved in SAS? Thanks, Ann.

Big Mono Lake Breakthrough

Audubon the Mono Lake Committee and LADWP Reach Important Agreement

Audubon's decades long battle to save Mono Lake saw a major breakthrough last month when the Los Angeles Department of Water and Power (LADWP) finally agreed to apply for dedicated funds from the State of California to invest in water conservation and reclamation programs and give up its claim to 35,000 acre feet of Mono Lake water. This landmark agreement marks a dramatic departure from years of hostility and mistrust, and will help meet the water needs of Los Angeles while protecting the fragile Mono Lake environment.

The agreement is founded upon legislation passed in 1989 that authorized \$60 million in state funds for projects to restore Mono Lake. Included in that figure was \$36 million for the LADWP to develop alternative water sources. But, the law required that both sides agree on what those projects should be. The understanding reached is consistent with our goals of fixing the water supply problem where it exists—in Los Angeles.

While this accord is extraordinarily significant, it does not yet mean permanent protection for the ecologically devastated Mono Lake. That protection rests in the hands of the State Water Resources Control Board. Until the Water Board makes its decision, this fragile and irreplaceable ecosystem is still in jeopardy.

However, this accord does not signal an end to the delayed strategies of the LADWP and their cabal of attorneys. Even as they have agreed to pursue alternative water sources to diversion from the streams of the Mono Basin, they are attempting to thwart the court mandated restoration of those streams.

From the beginning, LADWP's role on the RTC has been more destructive than constructive. As a Water Board decision nears that may be unfavorable to LADWP, their tactics are becoming more cynical and transparent. As of this writing, they are refusing to authorize a budget for the 1994 restoration season and are refusing to pay the consultants for much of the work done in 1993.

Apparently LADWP thinks that if they hold out long enough, those individuals contracted to repair the streams will just give up and go home. It is now up to Audubon, the Mono Lake Committee and CalTrout to go back to court to get the restoration effort moving again.

Wild Goose Chase Report

The Wild Goose Chase began Feb. 6 as a solo adventure. The air was damp, the weather cool, but the overcast clearing. The owls seemed to welcome the clearing weather and barely needed coaxing. The rails at Pescadero Marsh were equally cooperative and by the time I heard a Saw-whet Owl at Butano State Park, I had time for a quick before the dawn chorus began. Stell-Jay, Scrub Jay, Flicker, Robin and Varied Thrush started the dawn chorus well, but the other birds remained unconvinced that the weather was clearing. By the time I got to Pigeon Point, my list was a disappointing 27.

I was able to more than double my total at the Point, assisted by quick fly-bys by a Merlin and a Pomarine Jaeger.

I returned to Gazos Creek and Cloverdale Rd. where I found the birds more cooperative and picked up almost all of the expected species.

Quick excursions to Princeton Harbor and Crystal Springs Reservoir picked up some new species, but only one more that I could not expect to see again on the Bayshore. At Foster city, I wasted too much time looking for - and finally finding - one Red Knot and skipped Redwood Shores to go on to Charleston Slough. A Golden Eagle along the way buoyed me up, but Charleston Slough failed to produce some of its expected species and my after-dark sojourn to Palo Alto Baylands was a washout, leaving me with 152 species for the day.

Annual auto caravan through an isolated valley where relict populations of birds linger on despite destruction of their habitats. Phainopepla, Lewis' Woodpecker, Lawrence's Goldfinch, Golden Eagle & Prairie Falcon are near certainty while Roadrunner, Wood Duck, Purple Martin, Wild Turkey, Costa's & Calliope hummingbirds, Rufous-crowned, Sage & Grasshopper sparrows are likely. This all-day trip ends at dusk, so bring lunch & liquids. Weather is unpredictable, temperatures vary between 40 & 90 degrees this time of year; there are only 2 reliable restroom facilities, at lunchtime & mid-afternoon. A full gas tank is recommended, so be prepared. Take I-580 east past Livermore to Vasco Road exit. Take a right at the exit & follow Vasco Road to its end at Tesla Road. Take a right & follow Tesla Road for a little over 1/2 mile until you reach Mines Road on the left. We will meet at this intersection at 9am. Late arrivals will have no problem in catching up with the group if they continue on Mines Road.

Mono Lake Still Not Saved

I am often surprised and occasionally disheartened when friends and supports ask me: "Now that Mono Lake is protected, what is the Committee going to do?"

The answer is that Mono Lake is not yet saved—which means, of course, that the Committee has much more work to do.

We can achieve protection for Mono Lake only by winning permanent water flows that will restore a healthy ecosystem in the lake and one its tributary streams. Our courtroom victories have taken us a long way towards this goal, but we have not yet won permanent water for Mono Lake. That is why the current evidentiary hearings before the State Water Resources Control Board are so important. It is there that a final, binding decision can force the Los Angeles Department of Water and Power (LADWP) to relinquish its legal grip on Mono's tributary streams and keep the water flowing to Mono Lake-forever.

And yet I understand why so many friends may imagine that Mono Lake's protection is close at hand. The Committee's political news in recent months has been so spectacularly good that it's easy to feel victory is inevitable.

The first news came in early October when California Governor Pete Wilson surprised LADWP by taking a forceful stand in favor of full restoration of Mono Lake's public trust values. James Stock, California Secretary for Environmental Protection, testified on behalf of the Governor at the Water Board's October 4 hearing in Los Angeles, calling for a minimum protected level of 6390 feet but encouraging the Board to go even higher, if necessary, to comprehensively resolve the multitude of environmental concerns at Mono Lake.

Then several weeks later, the Commissioner of the U.S. Bureau of Reclamation, Dan Beard, came to California to announce the support of the Clinton Administration for Mono Lake's preservation. Affirming his agency's commitment to the full implementation of H.R. 429 (see Mono Lake Newsletter, Winter 1993), Commissioner Beard promised to fund up to 25% of the cost of

developing 120,000 acre-feet per year of reclaimed water in Southern California to replace LADWP's Mono Lake diversions.

Another shot of good news followed in late December. After more than 4 years of delay, L.A.'s political leaders finally agreed to join with the Mono Lake Committee in applying for State AB 444 funds to develop water projects in Los Angeles. Although the details of the joint application are being worked out [as this newsletter went to press], the breakthrough announcement headlined newspapers throughout the State. California's political leaders joined with the Committee at a landmark press conference on December 13 to pledge their support for the accord. Governor Wilson added his personal commitment to making the AB 444 funds available in the State's budget.

With all this good news, I understand why our friends may feel we are close to success. In the face of such remarkable political support, how could the Mono Lake Committee fail to win full protection for Mono Lake?

Saving Mono Lake requires translating this year's political support into permanent water flows for Mono Lake. All the support we gather contributes to our ability to win that water in the Water Board proceedings.

But we haven't won yet.

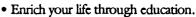

Field Trip Report

Altamont Pass 2/5/94

Leader - Nick Coiro

About a dozen birders enjoyed a fine day in the Altamont Pass area. A little fog was encountered but the day was mostly fine for birding activity centered on raptors. Most species expected were found except Prairie Falcons.

We enjoyed fine views of Merlins (including some aggressive behavior), dark morph Red-tailed Hawks, Ferruginous Hawks, White-tailed Kites (also some aggressive behavior) and Golden Eagles. Near the Bethany Reservoir we found a Red-shouldered Hawk - the first sighting of this species on trips I have led to this area. There were numerous sightings of American Kestrels and Northern Harriers. The day concluded with a less than satisfactory view of a Rough-legged Hawk. A total of 47 species were seen. Interesting non-raptor species included Mountain Bluebirds (many), Lark Sparrows, Common Snipe, Horned Lark and Rock Wren.

Highlights of the Feb. 3rd Board of Directors Meeting

The Committee reports included updates from the Conservation Committee on pending legislative environmental issues, and a very positive report on the successful first issue of the NEEDLES by our new co-editors Harriette Judge and Michaele Lee Huygen. The Board also voted to fund a partial scholarship to assist Bert McKee, a promising young SAS birder, to attend Camp Chiricahua. In other business the Board considered various issues including insurance coverage, adoption of a Car Pool policy and the organization of the SAS office.

Tricolored Blackbird Census Set For April 23rd.

The CA Dept.of Fish and Game's Tricolored Blackbird Working Group has taken notice of the success of the January 1994 California Mountain Plover Census, especially the important role of Audubon chapters and members. As a result they have asked the National Audubon Society's Western Reg. Office to help coordinate the first, single date, statewide census of Tricolored Blackbird nesting and foraging locations. The census will be held Sat., April 23, 1994. Your participation will make an important scientific contribution by helping to determine overall numbers of Tricolored Blackbirds, size and location of nesting colonies and foraging areas.

3436 Mountain Plovers found in California

A total of 3436 Mountain Plovers were counted in CA on Sat., Jan. 29, 1994, on the first, single day, statewide census. The census was coordinated by the Western Regional Office of the National Audubon Society. Several Audubon chapters and their members joined personnel from the U.S. Fish & Wildlife Service, U.S. Bureau of Land Mgmt., and CA Dept. of Fish & Game in providing census assistance and support. The Mountain Plover census was part of National Audubon's Birds in the Balance migratory bird program. Audubon Helps Save Lives

Public awareness is essential to reverse the downward spiral in the populations of songbirds. 50-90% of the birds that spend some oftheir residency in the U.S. have been lost due to loss of habitat.

Here in the Bay Area that translates to millions of birds, common ones like the white-and-golden-crowned sparrows and the lively wrentits that sound like a bouncing pingpong ball and live on the slopes of Mt. Tam and along wooded trails. Also disappearing are the colorful warblers that joyously announce mating time and brighten our days as one catches a glimpse of brilliant yellow, flashes of red-spotted breasts or black and grey streaked bodies.

Citizens can help reverse this decline by resisting the urge to fell trees or prune during the nesting time between mid-February and the end of May. If necessary, prune in early spring.

Audubon asks that one look first for evidence of nests by watching for activity such as birds carrying nesting materials or food. If a nest is suspected, avoid that area until the babes have left the nest. Additionally, provide food and water. Bird baths are a delight as one can watch the birds closely as they busily dip, splash and drink. If a tree has been removed, plant a native species or low- growing shrubs that will provide cover as well as insects and food.

Cat owners should keep their pet inside, have it neutered or place a bell around its neck. Every citizen can make a difference. Help save a life!

Backyard Birder

Getting Orioles to Visit

Anytime between April and September, a brief flash of color may be your first signal that your neighborhood is host to one of our most colorful bird species. But if you train your binoculars to the tree tops you may soon confirm the presence of a Bullock's or Hooded oriole.

In both species the male is a brilliant orange-yellow to lemon-yellow, two of the most colorful birds to visit our yards. They are well worth attracting because they will frequent your yard daily, even bringing their young by to learn the feeding ropes.

The Bullock's Oriole prefers oak woods and open area habitat, often near creeks or streams. City parks and neighborhoods with tall shade trees also host these beautiful birds. Their nest is a well crafted hanging basket made with fine grass, plant down, and hair. It is usually attached to a drooping

branch among the leaves and is so artfully placed than you won't even know of its existence until autumn, when the leaves have fallen and the inhabitants have flown south.

The Hooded oriole has a strong preference for tall palms with fanshaped leaves such as the Washington palm. Their nest is hung on the underside of one of the palm fronds, a small basket woven of wiry green blades of grass or palm leaf fibers. It may be lined with plant down.

Your real chance of regularly getting either of these birds seems primarily dependent on the availability of suitable nesting sites nearby. Late in the summer, the birds are seen less frequently as ripening fruit draws them farther afield in preparation for migration.

Both species are primarily insect eaters, but fruit and nectar are major supplements to their diet. Taking advantage of that with a piece of orange (sweet and overripe is best) placed on a nail or feeder with an appropriately spaced perch will often attract an oriole family to the yard. One customer on the Alameda in San Carlos was very pleased when he found several orioles tending some over-ripe pieces of pineapple he had chopped and tossed onto the comp pile a few hours earlier.

Many folks find out about this colorful summer visitor when they see a large bird trying to sip from their hummingbird feeder. Since they are very much over-sized for a hummer feeder, you can see some incredible contortions when they attempt to take advantage of this source. As it turns out, one of the most popular hummingbird feeders, the Perky Pet "Four Fountains" Number 203, is also one that has seems to consistently attract the attention of the orioles. (It must be the tacky plastic flowers.) Several folks from Nevada high desert report that they can't keep enough nectar in the feeder for the hummers, the orioles are so persistent. They even pull out the yellow bee guards to get at the nectar.

Nectar feeders designed specifically for the orioles are locally successful. We suggest that the nectar feeder be filled with a sugar water mixture similar to that provided for the hummingbi (four to one, water to table sugar). He that way you may get both hummers and orioles at the oriole feeder.

Some commercial oriole nectars have an orange scent and bright orange color, but the color of the feeder itself seems to be the primary attraction.

Feeder behavior is quite interesting in these species. The colorful males are quite cautious in approaching the feeder, giving a characteristic "chuck" call just prior to his arrival. As you might expect for such a conspicuously marked fellow, he seems almost paranoid, surveying the area before and after each sip. It's a wonder he ever gets fed. The slightest move, especially in the early part of the summer, will send him to high cover.

The females and young, including the young males, are much less nervous, hanging around relatively casually and even tolerating observers nearby, so long as they are quiet and not too close.

Can you imagine having these colors natives just on the other side of yokitchen window?

Conservation Report

Will Ducks Flock Back to Mono Lake?

After 20 years of expensive and bitterly fought battles waged by Audubon and the Mono Lake Committee against the Los Angeles Dept. of Water and Power, we may feel justified in thinking that we are much closer to success. In December a major breakthrough was negotiated; LADWP will give up 35,000 acre feet of water and invest in water reclamation and conservation measures. The Governor is one of those supporting the agreement.

However, two barriers to victory must still be overcome. First, the State Water Resources Control Board must still termine how much water it will allow LADWP to divert from Mono Lake. A final decision is expected in a few

months. The other hurdle is to convince the Governor's office to ensure that funding is secured under AB444 for this historic agreement with LADWP so that alternative water resources can be utilized. As of this writing, the Governor's budget proposes instead taking funds from the Habitat Conservation Fund for this purpose. ACTION: Write Governor Wilson and urge that the Mono Lake Committee-LADWP agreement be implemented using AB444 funds, and that the integrity of the Habitat and Conservation Fund be protected. Sequoia Audubon members have contributed to the Mono Lake campaign for many years. Let's make sure that our efforts have not been in vain. Write Pete Wilson, Governor, State Capitol, Sacramento, CA 95814.

Coastside Initiative for San Mateo County. The Save Our Coast Committee has been working to place

an initiative on the ballot that would further strengthen and clarify policies adopted by the voters in 1986 when Measure A was passed. This initiative seeks to extend coastal protection policies for scenic views and development controls to the Skyline area. For rural lands, water use would limit the density of development and sizes of houses, determined by on-site water sources. In urban mid-coast communities, smaller houses would be required on small substandard lots and height limitations would be adopted to protect coastal views. For rural Skyline lands, the rural coastal zone density limits would apply. This would be helpful in avoiding the kind of high fire danger exhibited in the East Bay hills. This initiative has been viewed favorably by the SAS Conservation Committee.
