

PRINCETON HARBOR The only sheltered harbor between Santa Cruz and San Francisco, is winter home to a good variety of bay ducks, loons, cormorants and other divers as well as gulls and shorebirds. Not only does the harbor usually have one or two surprises but the nearby willows, cypresses and grasslands have proven to be first-rate warbler traps. Clay-colored Sparrows, Palm and Prairie Warblers are only a few of the species that have wintered here in the past few years. Take Hwy 92 to Hwy 1 north to Capistrano Rd and turn left at the lights. Go past the marina, take the next left at Prospect Way/Harvard Ave. Follow Harvard west (a couple of blocks) till it ends at Westpoint and Stanford, where we will meet at 9 am. This will be a walking tour along the beach and rocks with some areas of broken footing, so boots or sturdy shoes are recommended.

For those birdwatchers traveling to Alaska, trips to St. Lawrence Island and the Pribilof Islands, both in th Bering Sea, offer exciting possibilities found no hwere else on the North American Continent.

Leslie Flint, an avid Sequoia Audubon birder, shares not only pictures of birds seen in these two locations on her trip there in 1991, but also tidbits about the anthropology, archaeology, and history of the people who live there.

Gambell, situated on the northwest cape of St. Lawrence Island is a village with 500 Siberian Yupik-speaking Eskimos who subsist hunting whales, walrus and seals. Birding at Gambell is an incredible experience and tantalizes th birder with possibilities of Asiatic birds and a mindnumbing passage of seabirds in the hundreds of thousands.

St. Paul, The Pribilofs, located about miles southwest of Anchorage is bited by 600 Aleut Eskimos. It is also home to the world's largest northern fur seal colony. Don't miss this fascinating program.

Camp Chiricahua

With financial help from the Sequoia Audubon Society I attended Camp Chiricahua in Arizona this summer. A 10-day long camp for young birders, Camp Chiricahua us located in one of the best birding spots in North America, Southeastern Arizona. During the camp we travelled all over this rich region, visiting such famous hotspots as Ramsey and Madera Canyons and the Patagonia Rest Stop. Although birds were the main focus at the camp, we studied all living things; some non-bird highlights included Ringtail, Coati, Black Bear, Gray Fox and many other mammals.

The mountains in Southeastern Arizona are a northern extension of the habitat in Mexico, so they attract many southern species found nowhere else in the U.S. Some of my favorite "Mexican" species that we saw included Elegant Trogon, a spectacular long-tailed, red and green bird, Gray and Zone-tailed Hawks, Montezuma Quail, Olive and Red-faced Warblers, Green Kingfisher, Vermillion Flycatcher, Rose-throated Becard, Varied Bunting, and Painted Redstart. The hummingbirds were amazing. We saw ten species in one spot and the trip total was thirteen, including the rare White-eared, Violet-crowned and Lucifer Hummingbirds. Owling was also good. We saw Burrowing, Spotted, Elf, Whiskered Screech, Western Screech, Northern Pygmy, Great Horned and Barn Owls.

My favorite bird of the entire trip may have been the Spotted Owl that landed right above the entire group! Although there are a few Spotted Owls in San Mateo County - I've actually heard them here - this was the first I've seen. My total of 60 life birds on the trip was astounding! I am grateful to the Audubon Society for their generous support.

Backyard Birder

Nesting Help for Larger Birds

Many of us enjoy helping the smaller songbirds with tree and shrub nesting locations, nest boxes and even nest materials. Larger birds suffer from the same habitat loss as their smaller cousins, and some species respond to the same types of nesting assistance. Given proper habitat and some effort, larger birds can often be attracted to a spot where their nesting activities can be observed and enjoyed by the family.

Woodpeckers

Our woodpeckers are primary cavity nesters, they create a nest cavity by excavating dead wood with their strong beaks. An excellent way to encourage them to nest nearby is to leave "snags," dead limb stubs on live trees, and dead trees for this use. Where these natural sites are not available, some woodpeckers can be enticed to use an artificial nest box. The best local nest box candidates are probably the Northern Flicker (Colaptes auratus) and the Hairy Woodpecker (Picoides villosus). The cavity size preferences for these species are quite different, so a species-specific nest box is recommended.

American Kestrel

Our smallest and most common falcon, the American Kestrel (Falco sparverius), is a secondary cavity dweller - they use cavities created by other birds, such as a Northern Flicker or Pileated Woodpecker (Dryocopus pileatus). The kestrel is a colorful and active bird, and readily takes to an artificial nest box. Kestrels require a good source of small vertebrates, mice and field voles, to feed their brood, so a location near an open field is often most successful. A kestrel pair are often seen hunting in the narrow strip of land between the railroad track and El Camino Real in San Carlos. Hoping to attract them, the Wild Bird Center located a nest box on the Kelly-Moore Paints building (look directly above the yellow Kelly-Moore sign on the highest portion of the southwest elevation). we've had no luck yet, but are still hoping. A kestrel nest box is fairly large - 8 X 8 inch bottom and 15 to 16 inch height with a 3 inch entrance hole. That means that they are heavy, so a solid tree or structure in an accessible location is necessary.

Screech and Barn Owls

Both the Western Screech Owl (Otus kennicottii) and the Barn Owl (Tyto alba) will accept nest assistance. The screech owl will nest in a box very nearly the size of the kestrel box described above. They are commonly found in open woodlands and near streams. They accept boxes near residences and pets don't seem to bother them. (One very successful local screech owl box was on a horizontal limb of an oak about ten feet from the ground only fifteen feet from a residence in a yard dominated by a frisky young German shepherd!) Screech owls predate on birds as well as small mammals, so you should be careful to locate the owl nest box some distance from other bird nesting locations in your yard. If you have the option, try to locate the box so can be watched. You may be able to observe the owls using the nest box as a roost during the cold winter nights as well as a spring nesting cavity.

Barn owls will use larger nest boxes (about the size of a small doghouse), and will nest in more open cavities in barns, attics and large buildings. Appreciating their services as mice and rat hunters, many farmers mount barn owl nest boxes on elevated structures around the farm. In our residential areas Barn owls often establish nests in palm trees where they raise their young in the flattened center portion of the tree top. It is not unusual to find them utilizing that same tree as a roost year around.

Waterfowl

If you are fortunate enough to have fresh water in a stream or pond, nest boxes for several waterfowl species are possible. Wood Duck (Aix sponsa), Bufflehead (Bucephala albeola), Common Goldeneye (Bucephala clangula) and Barrow's Goldeneye (Bucephala islandica)

are all candidates for nest boxes, although the Wood Duck is probably easiest to

Female Wood Ducks are reported to prefer nesting locations boxes near their own fledgling site. For that reason, sites just won't work. In addition, the box design, its mounting and placement relative to the water are all critical for successful fledgling.

Red Tail Hawk & Great Horned Owl

Both the Red Tail Hawk (Buteo jamaicensis) and Great Horned Owl (Bubo virginianus) use a shallow nest of sticks high in the crotch of a mature confier tree. In fact, they are direct competitors for nest sites, as well as for prey. Since suitable sites are not common, both species are likely to use an artificial nest platform. For the adventurous, a platform can be made by placing a cross board between two perpendicular limbs 20 feet or more above the ground. The area selected should be fairly free of small limbs so as to allow free access by these relatively large birds, but does not have to be in the very top of the tree. Filling in the triangular space by securely nailing chicken wire creates a floor. The nest is completed by placing sticks and limbs on the wire to create a stable nest platform

While you are thinking about Holiday Season, think about the larger bird species, too. Can you find a place to erect a large nest box, leave a snag for a woodpecker, or even allow a dying tree to stand for a few years? You can make a real difference in a bird's life!

Interested in hiking Montara Mountain/McNee Ranch State Park? Please allow us to introduce ourselves. We are Jill Forester, Chuck Kozak and Joe Barnwell, the co-chairs of a group of Sierra Club volunteers and coastside residents who are ready to serve as your ill guides on Montara Mountain.

The Sierra Club and the environmental community have been fighting for

decades to keep CalTrans from building a freeway bypass over Montara Mountain, which would bisect McNee Ranch State Park, deeply disfigure the mountain and lead to the urbanization of the San Mateo County coast. Our outings group is one of the many grassroots organizations determined to solve the problem - the occasional closure of Hwy 1 due to road failure at Devil's Slide - with the solution that makes sense for San Mateo County: a permanent repair of the road along its present alignment.

The members of our Outings Group have been trained in Montara Mountain lore and natural history. It is our goal to introduce others to the mountain's unique ecosystem with its endangered plant communities, abundant wildlife, historic road & trail crossings and spectacular ocean views.

Report from Cairo

Last month I participated in the United Nations Conference on Population and Development (ICPD). I was extremely proud to lead an Audubon delegation including four Audubon staff and seven grassroots activists to this watershed meeting in Cairo, Egypt. The conference produced a 20-year plan of action which makes stabilizing world population growth, improving the health and status of women, and charting a course towards environmentally sustainable development worldwide a concrete possibility. While the conflict with the Vatican over and abortion family planning overshadowed everything else in the world press, the conference made major strides in declaring the critical importance of integrating environmental protection, women's health and economic status, and

sustainable development into a collective set of goals, if we are to lower population growth. Getting 190 world leaders to recognize the critical interaction of these issues represents major progress.

Audubon played a real leadership role for the environment at the conference. I chaired several meetings, lobbied delegates and was the only U.S. environmental CEO to address the delegates as a whole. Pat Waak, Director of Audubon's Population Division, served on the U.S. delegation to the ICPD as the only NGO advisor from the environmental field. Tanya Thomas, Grassroots Coordinator for Population, co-chaired the U.S. Network for Cairo, facilitating the participation of citizens from across the United States and ensuring that different voices were heard in the ICPD process. Lisanne Nelson, Audubon's Population and Sustainable Development Specialist, coordinated the Environmental Caucus at the NGO Forum in Cairo, bringing together nearly 300 environmentalists from all regions of the globe to highlight environmental concerns. Audubon activists held workshops and networked with new colleagues.

The ICPD conference signals the return of the United States to a leadership position on population issues and sets the stage for work on a national population policy which will include bringing our own population and consumption into balance. The role of NGOs in policy making and creating innovative programs is clearly acknowledged in the official documents of the conference. Audubon's activities in fostering the partnership between local people, national governments and international bodies were specifically commented on by Tim Wirth of the U.S. State Department, who led the official U.S. delegation.

Audubon will be hosting a follow-up population conference for NGOs and activist as part of our National Convention in Florida next month. Entitled "The Road from Cairo," this meeting will be a unique opportunity to organize groups in this country to work effectively together to carry out the mandates from Cairo, including laying the groundwork for a U.S. national population policy. I hope to see you in Florida next month, along with 1,000 other Auduboners from around the country.

Dealing With Squirrels, Part II

As president of the newly conceived Squirrel tolerance League, it behooves me to address the issues raised by the Backyard Birder in the November 1994 newsletter.

Evolutionary Leaps

Mr. Held suggests that to outwit the squirrel, bird feeders be placed at a

distance greater that the five foot range. Junior lands lightly in the sunflower seeds, munches contentedly, and in between, practices his overpaw, ninety-miles-anhour return of seeds to home base. Besarubu the way it otta be!

Location

habitants of my backyard. Anticipating the "problem" suggests eternal vigilance against the vicissitudes of rampaging beasts out to get the sparrow's seed. Rather anticipate the variety and diversity of the backyard, and wish there were m – for all too soon, there may be none.
