DID YOUR SHOPPING LIST KILL A SONGBIRD?

Though a consumer may not be able to tell the difference, a plump red tomato from Florida is often not the same as one grown in Mexico. Imported fruits and vegetables found in our shopping carts in winter and early spring are grown with types and amounts of pesticides that are usually illegal in the United States.

The victims of these pesticides are North American songbirds. Bobolinks, also known as skunk blackbirds, were once a common sight in the Eastern United States. In mating season, the male in his handsome tuxedo-like suit sings deliriously as he whirrs madly over the hay-fields. Bobolink numbers have plummeted almost 50 percent in the last four decades, according to the North American Breeding Bird Survey.

Bobolinks are being poisoned on their wintering grounds by highly toxic pesticides. Rosalind Renfrew, a biologist at the Vermont Center for I costudies, captured Bobolinks feeding in rice fields in Bolivia and took samples of their blood to test for pesticide exposure. She found that about half of the birds had drastically reduced levels of cholinesterase, an enzyme that affects brain and nerve cells – a sign of exposure to toxic chemicals.

Since the 1980s, pesticide use has increased five-fold in Latin America, as countries have expanded their production of nontraditional crops to fuel the demand for fresh produce during winter in North America and Europe. Rice farmers in the region use monocrotophos, methamidophos, and carbofuran, all agri-

cultural chemicals that are rated Class I toxins by the World Health Organization. These pesticides are highly toxic to birds and are either restricted or banned in the United States.

A single application of a highly toxic pesticide to a field can kill seven to 25 songbirds per acre. About half the birds that researchers capture after such spraying are found to suffer from severely depressed neurological function.

Testing by the U.S. Food and Drug Administration shows that fruits and vegetables imported from Latin America are three times as likely to violate Environmental Protection Agency standards for pesticide residues as the same foods grown in the United States. American consumers can discourage this poisoning by avoiding foods that are bad for the environment, bad for farmers in Latin America, and bad for their own families.

What should you put on your bird-friendly grocery list? Organic coffee, for one thing. Most mass-produced coffee is grown in open fields heavily treated with fertilizers, herbicides, fungicides, and insecticides. In contrast, traditional small coffee farmers grow their beans under a canopy of tropical trees, which provide shade and essential nitrogen, and fertilize their soil naturally with leaf litter. Their organic, fair-trade coffee is now available in many coffee shops and supermarkets, and it is recommended by the Audubon Society, the American Bird Conservancy, and the

Smithsonian Migratory Bird Center.

Organic bananas should also be on your list. Although bananas present little risk of pesticide ingestion to the consumer, the environment where they are grown is heavily contaminated by pesticide use.

When it comes to nontraditional Latin American crops like melons, green beans, tomatoes, bell peppers, and strawberries, it can be difficult to find any that are organically grown. We should buy these foods only if they are not imported from Latin America.

Now that spring is here, we take it for granted that the birds' cheerful songs will fill the air when our apple trees blossom. But each year, as we continue to demand out-of-season fruits and vegetables, we ensure that fewer and fewer songbirds will return.

Fall Birding Classes in San Francisco

Evening birding classes taught by Joe Morlan and endorsed by Golden Gate Audubon Society will be starting September 9, 10, and 11, 2008. All classes meet 7-9:15 PM in room 307 at Marina Middle School, 3500 Fillmore at Bay St. Free parking is in the school lot off Bay St. on the east side of the building.

The instructor is co-author of *Birds of San Francisco* and the *Bay Area and Birds of Northern California*. He is also coordinator of the recorded "Northern California Birdbox" sponsored by Golden Gate Audubon Society. Slides illustrate all lectures, and the text for all classes is *A Field Guide to Birds of North America*, fifth edition, by the National Geographic Society. *The Sibley Guide to Birds* is recommended as an adjunct text for Ornithology II & III.

Field Ornithology I meets on Tuesdays. It is an introduction to birds and birding, combining basic field skills with the study of bird ecology, biology, evolution, and behavior. Part A (EA101) starts September 9 and ends October 21; Part B (EA105) is a continuation of Part A. It begins October 28 and ends December 16.

Field Ornithology II meets on Wednesdays. It is a continuing in-depth study of the identification and status of North American birds including terns, jaegers, alcids, pigeons, and parrots. Part Λ (EA110) starts September 10 and ends October 22; Part B (EA115) starts October 29 and ends December 17.

Field Ornithology III meets on Thursdays. It is a continuing study of North American land birds including juncos, long-spurs, grosbeaks, buntings, blackbirds, and orioles. Part A (EA120) starts September 11 and ends October 23; Part B (EA125) starts October 30 and ends December 18.

The instructor may arrange optional field trips on weekends. Please bring binoculars and field guides to class if you have them. Fees are \$140 for each seven-week course (\$125 for EA120 which is six weeks), with a \$10 discount if you preregister at least a week early. Pre-registration is strongly advised. SWAINSON'S HAWK MIGRATION IN ANZA BORREGO STATE PARK



During the last week of March 2008 my husband Bob and I camped at Anza Borrego Desert State Park. It's located northeast of San Diego.

We were a week or two late for the best wildflower display in the valley, but took some nice hikes up into the canyons and saw some colorful flowers, especially blooming cactus.

One particularly interesting sight in the valley was witnessing the Swainson's Hawk migration. The local birders count the hawks as they fly in every evening and fly out after sunrise during the months of March and April.

We learned that the Swainson's Hawk winters in South America and returns to breed in the Western and Midwestern US and Canada. Every evening starting at about 6:00pm the hawks can be seen coming in at a high altitude. They spiral down to the desert washes to feed on insects and caterpillars and then roost overnight in the nearby trees — mostly tamarisk. We witnessed about 300 hawks flying in over a period of an hour. As they flew overhead we could see the various color phases from light to dark.

When we first arrived in the desert and saw the 4 to 5-inch long Sphinx Moth caterpillars eating the wildflowers we were unhappy but realized later that they, in turn, were providing a meal for the hawks.

Conservation Program

Open Space Vote in Redwood City

A group of conservation organizations, including Sequoia Audubon Society, have joined together to put an Open Space Vote measure on the ballot in Redwood City for the November election. The purpose of the measure is to allow Redwood City voters to have the final say on any proposal to develop on city parks, open space, or baylands. Any development placed on open space land would need to be approved by a two-thirds vote. Building or expanding public recreation facilities on open space will not require a vote.

The Conservation Committee sent information and petitions to all our members who live in incorporated Redwood City asking for their help in collecting signatures to qualify this measure for the ballot in November. If you received one, please do your best to sign and return it. Get your friends and neighbors to join in.

The Open Space Vote supporters need to collect about 5,500 signatures, which is 15% of the people who voted in the last election. As of last weekend, they were halfway to that goal. Give them a hand in this endeavor. It will be a boon for our local birds.

Redwood City General Plan Update

The City of Redwood City is in the process of updating its General Plan. This update may well affect lands that are currently zoned as Open Space. The Plan has many implications for traffic patterns, intensity of development, possible daylighting of creeks, as well as potential rezoning of the Cargill Salt Flats. The City has a number of affinity group meetings scheduled. I attended the one for environmental groups held in early April. The City heard from developers and builders the day before.

In attendance at the meeting wherein I represented Sequoia Audubon were representatives of the Friends of Redwood City, Sierra Club, Greenbelt Alliance, and the Committee for Green Foothills. A number of issues were on the table including support for public transit and development in transit corridors. There was complete consensus among environmental groups represented that open space remain open and that the Cargill site retain its open space zoning and be returned to wetlands.

The General Plan update is slated to take months. Updates on the process may be found on Redwood City's website, http://www.redwoodcity.org/cds/planning/generalplan.html.




